If you are an appointed administrator, you are responsible for the estate and may be asked to post a guarantee bond, which is a contract that protects the heirs and creditors of the estate and is based on the amount of assets. Where can I get a certified copy of a death certificate? - You can obtain a certified copy of a death certificate from local registrars for the municipality where the death took place, or you can also obtain them from the New Jersey Department of Health and Senior Services (vital statistics). What documents do I need to make a will? - If you are the named executor of the property, you must present the following documents to the Court of surrogate: the original will, the death certificate with an elevated stamp, the photo ID, the names and addresses of the deceased's next of kin (including the children of the deceased deceased's deceased children) and the deposit fees. Can an executor or administrator receive compensation for his services? - There is no doubt that being an executor/manager is a time-consuming job, especially if the person has a full-time job or family at home. An executor/administrator is entitled to an income commission and a corpus commission under New Jersey law. The laws of the state have established a timetable in which compensation is determined by the value of the property. What happens when someone has a small fortune and no spouse or domestic partner? - When someone dies without a will and they do not have a surviving spouse or domestic partner, but they have heirs and the value of their property is less than \$10,000.00, then with the consent of other heirs they can obtain an affidavit of Next of Kin instead of filing for an official administration. What people have the right to be appointed when someone dies without a will? - Either the spouse or the partner has the first right; however, one of the heirs may be appointed, provided that other heirs who have an equal or prior right give their consent. Do I need to send copies of the will to the beneficiaries? - Within 60 days of the examination of the will, the personal representative is obliged to take out the letters of the administration; inform relatives, heirs and beneficiaries that the will is being investigated; notify them of the date and place of ratification; and make a declaration that a copy of the will must be Request. In addition, a receipt of correspondence must be filed with the surrogate's office. What is validation? - Probate is the process by which the surrogate accepts a will. What is management? - Administration is the appointment of a person to manage a property if there is no will. What can I do if I believe that a false will or a will that is the subject of unjustified is it going to be probated? - File a warning. A warning is the name of the notice given by a party that is interested in an officer telling the party not to act until the part giving the notice has been heard. A warning asks that the validation judge does not prove a will, or grant administration letters until the party is heard. What happens after a warning is filed? - One or the other party must file a legal action in order to proceed further.
