FOR YOUR SAFETY, AT ANYTIME DURING THE RENTAL IF THE CAPTAIN FEELS YOU ARE IN DANGER FROM INTOXICATION, HE MAY END THE RENTAL OR CALL HELP. **CONTENTS OF RENTAL BOAT:** UP TO 8 REGULAR ADULT AND/OR 1 CHILD SIZED LIFE JACKETS ON BOARD (ALL STANDARD—IF YOU HAVE A SMALL CHILD OR LARGE ADULT YOU MAY NEED TO PROVIDE YOUR OWN LIFE JACKET FOR COMFORT FIT), EMERGENCY HORN, FIRST AID KIT, FIRE EXTINGUISHER, MAP OF LAKES, OWNER'S MANUAL, INNER TUBES, EMERGENCY SUNSCREEN, FRIZBEES, AND BOAT CAPTAIN. **CLEANING:** YOU HAVE OPPORTUNITY TO CLEAN BOAT AT END OF RENTAL TIME, IF EXTRA EFFORT TO CLEAN BOAT IS NEEDED THAN USUAL \$50 CHARGE TO THE CARD OF FILE WILL BE IMPLEMENTED. **PAYMENTS:** RENTAL MUST BE PAID IN FULL BEFORE RENTAL TIME BEGINS.
