What we talking about?

- Child / Colt = Anyone under the age of 18 years old
- Safeguarding = is the action that is taken to promote the welfare of children and protect them from harm.
 Safeguarding means: protecting children from abuse and maltreatment. ... ensuring children grow up with the provision of safe and effective care
- Child protection = the process of protecting individual children identified as either suffering, or likely to suffer, significant harm as a result of abuse or neglect. It involves measures and structures designed to prevent and respond to abuse and neglect.

- Provide physical support / touch a child? Yes when would this be appropriate?
- Take a child home? No but may need to consider depending on the circumstances. What are these circumstances?
- Transport one child on their own? No What could you do? Put them in the back and speaking to a family member while you drive
- Contact a child directly? No all contact should be made through a parent . If over 16 and with parent consent. Where would you find parent consent?
