INSTRUCTIONS

PURPOSE--The purpose of filing the "Declaration of Estimated
 Pemberville Income Tax" to reduce that taxpayer's tax liability for
 the current taxable year. Per Ordinance 1543.07, every taxpayer
 shall make a declaration of estimated taxes for the current taxable
 year, if the amount payable as estimated taxes is at least two
 hundred dollars. For example, if your income is \$8,000.00 per year
 you pay \$20 in April, June, September and December. Taxpayers
 filing joint returns shall file joint declarations of estimated taxes.

You pay 1/2 at the time the Estimate is filed and each quarter
 thereafter. Your estimate can be amended at any payment time that your
 income changes so as to increase or decrease your payments. Any
 difference between your estimated income and actual income can also be
 adjusted when your return is filed.

**HOW TO MAKE OUT YOUR DECLARATION OF ESTIMATED
 PEMBERVILLE TAX**

If the books are kept on a fiscal year basis differing from the
 calendar year, show the number of months you are reporting and
 the date on which your fiscal year ends. Make any necessary
 corrections to your name and address as imprinted on the form.

CALCULATION OF INCOME AND TAX

1. Enter here the total estimated income subject to Pemberville Income
 Tax
2. Enter here 1% of amount shown on line 1.
3. Enter here tax to be withheld by employer for Pemberville.
4. Enter here the difference between 2 and 3.
5. Enter here overpayment from prior year return.
6. Enter here the difference between lines 4 and 5. If this line is -0- do not
 file Vouchers with the Commissioners.
