 - Bob Long attended Insurance Forum:
 - People are getting insurance. It's being written: Lloyds of London, CA Fair Plan (have wrap policy to ensure you're covered). If you get denied, other brokers may be able to help you b/c they have different carriers.
 - CA Fair Plan (10% discount for new policies) will deny you if work needs to be done (deferred maintenance); or legal business on property; or single family dwelling & have multiple families living on the property
 - USAA (vet insurance) is writing policies. 5% discount for Firewise Communities.
 - There's an insurance service protection class on line.
 - Sign up for Code Red (see mynevadacounty.com button on home page)
 - o Complete requests for those shovel-ready projects, send to Fire Safe Council.
 - Promote the FSCouncil to your residents: \$49 membership, reflective address signs

- Trisha grew up in NC, has an engineering background and has been with county 3 years.
 - Road Maintenance: 560 miles of county roads, and 3X as many private roads not maintained by county). 38% of roads don't meet today's standards. Road maintenance funds are mainly gas tax funds and vehicle

license fees. Road Maintenance info: "mynevadacounty.com," then click on "my neighborhood" button.

- o Vegetation maintenance is on par for spending past and future years.
 - Public roads: 70 miles/year (10 feet each side of road), not including grant funding
 - County responsible for 10 feet of vegetation clearance
 - Grant funds allow more clearance: FEMA & FSC grants, but they are minor.
 - Property owners can maintain veg. on public road easement.
 Will cost county more \$ to do this. NEED property owners to Participate.
- o County Spray Program: on website, public works page. In exchange for not spraying, you sign agreement to maintain vegetation.
- Private Roads: homeowners must maintain.
 - 100 feet Defensible Space shared by property owners
 - Adjacent parcels could have hazardous fuels abatement process @ property owner's expense: 100% (lien on property).
 - Options for maintenance:
 - Road Maintenance Agreement
 - Road Association
 - Homeowner's Association
 - Informal agreement, as needed.
 - Permanent Road Divisions or County Service Area
- Kent Rees: "No one wants to drive through a flaming tunnel. Veg. Maintenance needs to be a priority."
 - Talk to Supervisors re improving veg. maintenance (via tax, etc).
 - Needs to be driven by community group
- Chris Reilly/Alta Sierra:
 - Evac routes some on OES website. Work w/ Fire Dept on routes.
 Private roads = homeowners pay their fair share. Work with Public Works for county road clearance.
 - Alta Sierra working on evac signage.
