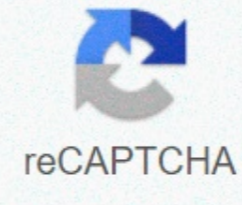

The office identified the bodies, notified relatives and returned personal belongings to the family. They also work with the Dallas County sheriff's office and the sheriff's office to investigate suspicious or violent deaths. Dallas County Medical Examiner & Coroner creates death records that can be used in criminal investigations, to address insurance requests or to monitor Dallas public health. Addison Police are investigating the death of a disabled woman in her 80s as a homicide. Eric Ridenhour and his fiance Kiersten Smith were enjoying a lazy Sunday in their apartment when a crane crashed into their downtown Dallas complex. A man was electrocuted in Waxahachie Sunday night after being exposed to high voltage wires while jumping roof, police said. A Cedar Hill pastor who had his body found inside his burning home last February has died from a self-inflicted gunshot wound, according to the Dallas County Medical Examiner. Two daughters and the pastor's wife, who died in the fire, its origin remains unclear. Friends and family members are preparing to put a beloved pastor, his wife and daughter to rest. The circumstances surrounding their deaths remain a mystery. It has been a month since a Grand Prairie couple were reported missing from their home. Investigation into a triple fatal house fire that injured a fourth person in Cedar Hill Thursday has moved to a criminal investigation, police said. According to an arrest warrant testimony obtained by NBC 5 Monday afternoon, Amber Guyger issued a verbal order to a person inside a dark apartment she believed was her own before fatally shooting him. One person has died after a fire early Sunday morning that reduced a house in South Dallas to rubble. There are two forensic pathology scholarship positions available each academic year as well as rotation of residents and students. Regular scheduled conferences include general and microbial neuropathy, seminars, cardiac pathology and case review conferences.
