All files in the taxonomic package are also available in their canonical locations posted on the ESMA website. The Corporate Disclosure European Unified Electronic Format ESEF Reporting Guide is intended for all market participants involved in the implementation of the requirements set out in the ESEF Devolution Regulation, and in particular for the first time the preparation of consolidated IFRS financial statements in Inline XBRL. The ESEF Reporting Guide is designed to provide guidance on the issues that are commonly encountered when creating documents for the Inline XBRL copy in accordance with the ESEF Delegated Regulation. It was originally published by ESMA in December 2017 and updated in July 2019. ESMA will continue to monitor the development of markets and collect feedback from stakeholders.
