The Superintendent oversees Arizona's public school system and leads the state's Department of Education. The current superintendent is Democrat Kathy Hoffman. Hoffman took office On January 14, 2019, she was replaced by Diane Douglas (R), who lost the Republican primaries on August 28, 2018. Hoffman won the general election on November 6, 2018. The power of the Superintendent's position is established by the Arizona Constitution as part of the state's executive department. The Arizona Constitution, Article 5, Section 1 (Version 2) The Executive Department must consist of the Governor, the Secretary of State, the State Treasurer, the Attorney General, and the Superintendent of Public Education... The qualification of the Arizona Constitution requires that all officials in the state's executive department, including a superintendent of public education, are at least 25 years old, a U.S. citizen for 10 years, and an Arizona resident for five years. The Arizona Constitution, Article 5, Section 2. No person is entitled to any of the offices mentioned in section 1 of this article, except for a person of at least twenty-five years of age who was required in the ten years preceding his election as a United States citizen and for five years prior to his election as an Arizona citizen. Arizona's election elects them the superintendent of public education in the midterm elections (2006, 2010, 2014, etc.) for a four-year term. The winner takes office on the first Monday in January after his election. If no candidate wins a majority (more than 50 per cent) of the vote, a second round of elections is held between the two candidates with the highest number of votes. If two candidates in the second round receive the same number of votes, the state legislature chooses the winner. The Arizona Constitution, Article 5, Section 1 (version 2) of the Executive Department consists of the Governor, the Secretary of State, the State Treasurer, the Attorney General and the Chief of Public Administration, each of whom must hold office for four years, starting on the first Monday in January 1971 after the regular general election in 1970. B.B. Person, gaining a majority of votes cast for the position for which they voted, is elected. If no person receives a majority of the votes cast for the post, a second election shall be held between the persons receiving the largest and second highest number of votes cast for the post. Former officials can run again after they are left out of office for one full term. Jobs Article 5, Section 8 of the state constitution allows the governor to fill vacancies as superintendent by appointment. The superintendent of public education oversees and administers the Arizona Department of Education, which administers the state's public school system. His general responsibilities include managing the department's employees. Other specific responsibilities listed by the law include: the implementation of a policy established by the State Board of Education. Annual allocation of public funds for education to individual districts. Distributes school materials, training courses, administrative information, teacher certificates and other subjects in individual school districts. Audit the accounts of school officials across the state with the help of the auditor general. Compensation See also: Compensation to state executive officials for the salaries of the superintendent and other elected executives in Arizona is determined by the Arizona Pay Commission for elected public servants. This five-member committee is sanctioned by Article 5, Section 12 of the Arizona Constitution. Two members are appointed by the Governor and one member each is appointed by the President of the Senate, the Speaker of the House of Representatives and the Chief Justice of the Arizona Supreme Court. Members meet until June 1 of each preliminary year to prepare salary recommendations for the Governor. The governor can accept, reject or change the recommendations before delivering to state legislators. The Legislature has 90 days after the governor sends recommendations to reject or amend wage proposals. If no changes are made, the commission's recommendations will take effect after the next election. According to the State Council, the chief received a salary of \$85,000 in 2016.
