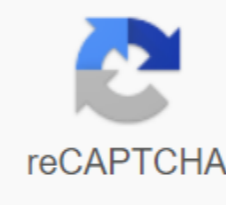

## Mdc dependent verification worksheet

Confirmation is a review process in which the Department of Financial Aid has reported from student/parents that it determines the accuracy of various data elements described by students on the student's free request for federal student assistance (FISA). The U.S. Department of Education selected nearly 30 percent of all aid applicants for confirmation. During the verification process, students and parents will need to submit documents to verify information about the financial aid request. The certification process ensures that qualified students receive all the financial support they deserve. In general, students can be expected to receive information that they are selected for certification within 14 business days when the results of student fissa in the Office of Financial Assistance are obtained by federal processors. The Office of Financial Assistance notsstudents who have been selected for verification via e-mail and can also review their status through their application tracking (student portal). The tracking letters will direct the student to submit the required documents to their financial assistance office and or to the relevant departments (such as admission/registration, testing, consultation). Since the year of education support exceeds the calendar year, please refer to your online account for the appropriate form and documentation of the year. All documents must be fully submitted to the financial aid offices within 30 days of their complete signing and physical or electronically submitted information. If you do not collect the information requested as soon as possible, you may otherwise lose the money available to you. See the verification form. Professional decision if you have a tenoatang condition, which you believe is guaranteed to review your eligibility for financial assistance, you must inform the office of financial assistance as soon as possible. Please complete and submit the form with the appropriate supporting documents in your financial aid office. If additional documents are required, it must be presented within 30 days from the application date to avoid delay in processing. If your recent year's request was selected for verification, the verification process must be completed before a professional decision. This application will not waive the requirements of the General Student's qualifications. Your request will be reviewed and you will be notined about the decision via email. If there are unusual circumstances, the dependent college can deny a student's dependent status for federal funding purposes. If you believe you have tenoatang conditions that guarantee your dependency status, you must inform the Office of Financial Assistance as soon as possible. Please complete and submit the form with the appropriate supporting documents in your financial aid office. If additional documents are required, it should be submitted within 30 days of the request. To avoid delays in processing, if your recent year's request was selected for verification, the verification process must be completed before the dependency can be applied. This application will not waive the requirements of the General Student's qualifications. Your request will be reviewed and you will be notined about the decision via email. To ensure priority dates, there is enough time to implement the records of the financial assistance team, all documents must be submitted to the Finance Office for eight weeks before the term begins. This formal verification can be used for you in housing, income tax, financial aid, employment, loans and similar matters. How do I get confirmation?
