The process is this: Contact the Company and Intellectual Property Management (CIPA), offering 3 promising company names. You can search for names online in the database of the Ministry of Industry and Trade. When applying to the Company Registrar, the applicant must receive a response within 3 days. Once approved, the company's name is reserved for 30 days. Receive a declaration of compliance with the statutory requirement signed by a representative of the company to register with the Oath Commissioner. Send the company's registration form, consent to act as shareholders, directors, auditors, company secretary and registered officials along with their national identity card or passports, as well as a declaration of compliance with the company secretary's license practice, to the Company Registrar. The site is then inspected by the Department of Industry (Department of Trade and Industry), the Department of Health, the Department of environment and the Department of Urban Planning. This should take about 7 days. Get an industrial license from the Department of Industrial Affairs or a trade license from the city council. Open a corporate bank account for the company. If they are registered and are not active and working at the same time, it is expected that directors and shareholders will comply with the Botswana Companies Act in terms of submitting all necessary forms for a change in directory, equity, registered office, etc., including annual profits. The online registration system does not entertain the sleeping registration of the company. If online forms and refunds are not filed or updated on the grounds that the company is not working, then CIPA will deregister companies. Therefore, the goal is to keep the current list of operating companies and those that intend to operate. Even if they do doze off, all forms and refunds must be filed in order to confirm the company's registration. In this case, you run the risk of escape.
