How to get a certificate of transfer of the car? This document, called CERFA 15776-01, is available for free on the ANTS website. Be careful if you use a form printed a few years ago it is important to make sure that it carries the number CERFA 15776-01. Indeed, since September 2017, the form of deer No. 15776-01 has replaced the number 13754-03, which is therefore no longer valid for the announcement of the transfer of the vehicle. Prior to the application of the Procedural Dematerialization Act, the form for the sale of the vehicle consisted of only two copies, whereas in the past three identical copies were required. The reason for this change is that the owner must now download the declaration of the transfer of the vehicle directly from the ANTS website and is no longer in the prefecture, as was the rule a few years ago2. Who should fill out a car transfer certificate? The current owner of the vehicle is responsible for completing the vast majority of the CERFA 15776-01 form. In particular, it must scrupulously fill the part relating to the vehicle. This part can be filled before the day of sale. Registration number, vehicle identification number (VIN) and date of first registration must be provided. Then, four boxes are designed to indicate the type of car sold (brand, type, national genre and trade name). To help you write this part of the document, you can check your car's gray card (so-called registration certification). Write the numbers and letters clearly so that there are no errors in checking the return of your vehicle. Ideally, all the data is entered directly on the computer and then printed form3. What fields fill the day of sale? On the day of the transaction, in the presence of the buyer, it is necessary to record the number of kilometers specified at the level of a meter. This information was not required in the previous form. Other conditions were added with the introduction of CERFA 15776-01 . The owner can contact ANTS. The box must be checked by the buyer to ensure that they purchased the vehicle on the dates and times specified by the previous owner - the box must be checked by the new owner certifying information about the administrative situation of the vehicle. What are the necessary parts to complete the transfer declaration? The owner must take certain steps before making an appointment with the buyer. When selling a car, the law requires a

technical check starting less than 6 months for any vehicle over 4 years of age. In the case of a counter visit, the check should be carried out less than 2 months before the day of sale. Obviously, in case the car is destined to be destroyed, there is no need to do a technical check. On the other hand, it is necessary to find out in the certificate of transfer of the car the registration number of the VSU center (Vehicle out of use) where the car will be deposited. On the day of sale, the owner must submit an administrative status certificate of up to 15 days. A prohibited grey card with a ceded inscription, followed by the date and time with the owner's signature, must be handed over to the buyer. 5. Why bar a gray card before giving it to a new buyer? Violation of the registration certificate allows the former owner to absolve himself of responsibility in case a violation of traffic rules (or an accident) is committed after the actual transfer of the vehicle. This protects him and he will not be required to pay fines or damages to others. Thus, forgetting to scratch the gray card, it can have significant legal consequences for the seller, especially since in general he canceled the car insurance on the day of sale. For the buyer, a prohibited grey card must be submitted in the event of a police check before a new registration certificate is obtained in his name. 6. Where to file a certificate of transfer of the car after completion? Once the vehicle transfer certificate is properly completed and signed by both parties, it must be scanned and uploaded to the ANTS website. To access this site, you need to create an account or you can use FranceConnect identifiers. This site invites you to create a single account that will be recognized by all online public services, including ANTS. Ants.
