Just a decade ago, it cost thousands of dollars for women to be tested for BRCA 1 and BRCA 2, genes associated with breast and ovarian cancer. Color Genomics screening tests are only \$249.Instead, Color Genomics, a startup founded by veterans Twitter and Google, wants to win over patients and providers with an easy-to-use interface. On Wednesday, the company launched a new service for health providers to order, track and view patients' genetic test results. By going to the website, doctors can check if the sample has arrived at a Burlingame Color Genomics, California, laboratory, and whether the patient has been connected with a genetic counselor to receive the results. In the past, doctors usually needed to fill in a broad family history for each patient as well as provide insurance information. The results will be shared by fax. But now, doctors who order tests from Color Genomics can see the status of the test online. In addition, the test is designed to be cheap enough so that patients don't need approval from their insurance provider - many payers will only cover the test if someone has a family member with cancer or mutation - and see a similar set of metrics as they wait for the results. Logistical ChallengeSIni sort of transparency in terms of price, production, and logistics is rare in the field of laboratory testing. Test prices are not often shared; samples are sometimes mily; and research has shown that doctors will sometimes forget to pass on test results to patients. Our strategy is to take best practices from ecommerce sites and apply them to health care, Gil said. But e-commerce does not face complex regulatory requirements in how they store and share data. Gil said that the company complies with HIPAA, the laws governing sensitive health information is shared among health providers and their business associates. We do not share patient information without permission, he said. Strong CompetitionColor Genomics was launched in April 2015 with \$15 million from investors in the bank. The company quickly made a name for itself in health care to focus on software and services. But it's far from alone.
