Page 2 of the jury's standard instructions are made public by the Florida Supreme Court committees and approved by the court. Florida Bar publishes civil and criminal jury instructions and the Florida Supreme Court includes instructions and updates on its website. Jury instructions can also be helpful in determining elements of a crime or action, and also contains diagrams that show a smaller included offense. The American Bar Association has published a number of books on model jury instructions on topical areas of practice as shown below. To find other books on the jury's instructions, look in the library catalog, by themes: Instructions for Jurors (State) or Instructions for United States Jurors for Federal Editions. Both Lexis and Westlaw have folder databases on jury instructions. There is a lot of overlap, but check each service to see what is covered. Lexis Jury Instructions Westlaw: Jury instructions can be found by moving to a secondary source link and then selecting a jury selection from the options listed on the left side of the page. This Jury Instructions Builder was developed by the United States District Court for the Southern District of Florida, using the contents of the civil jury template instructions authorized to distribute the Eleventh Circuit Judicial Council in May 2013, and the contents of the criminal template of the Jury Instructions authorized to circulate the eleventh Circuit Judicial Council in April 2016. The Eleventh Circuit Judicial Council authorized the Judicial Council's Panel on The Court's Panel guidelines to provide instructions on the civil and criminal template of the jurors to the district judges for their assistance and assistance and otherwise to publish instructions; however, provided that his authorization is not construed as a judicial assertion of the contents of such instructions, which must await the Court's consideration on a case-by-case basis.
