See BNF for children for proper use and dosing in specific populations, such as liver disorders, kidney disorders, pregnancy and breastfeeding, and the introduction of intravenous (or, where appropriate, intramuscular) antibiotics. 2 Age groups apply to middle-sized children, and in practice, prescribing will use age ranges in combination with other factors such as the severity of the condition and the size of the child relative to the average size of children of the same age. Oral doses for immediate release of drugs. 3 Give oral first-line antibiotics if a child or young person can take oral medication, and the severity of their symptoms does not require intravenous antibiotics. 4 If flucloxacillin oral solution is not allowed due to poor goodness, consider capsules (see Medicines for Children flyer for helping your child to swallow pills). 5 Based on a clinical evaluation, a longer course (up to 14 days) may be required. However, the skin takes some time to get back to normal, and a full resolution of symptoms for 5 to 7 days is not expected. 6 If intravenous antibiotics are given, review for 48 hours and consider switching to oral antibiotics if possible for appropriate course duration. 7 Co-amoxiclav 400/57 suspension can also be considered to allow twice-daily dosing (see BNF for children dosing information). 8 Infection around the eyes or nose (triangle from the nose bridge to the corners of the mouth, or directly around the eyes, including periorbital cellulite) causes more concern due to the risk of serious intracranial infection. 9 Other antibiotics may be appropriate based on microbiological results and expert advice. 10 See BNF for children to obtain information about therapeutic drug monitoring. 11 See BNF for children to obtain information about patient monitoring. 12 Is not licensed in children and young people under the age of 18, so the use will not be labeled.
