Referring to a Chicago-style website requires you to include most of the same information you would be referring to a printed resource as an author (s)/editor (s), website name, information publisher, etc. This information can be hard to find on the website, so you may have to look around a bit to find the information. The Chicago style also requires you to include the date when you access the website and/or publication date (if any) and the website uRL. There are, however, some exceptions: the names of blogs are set in pages and the titles of books, magazines, television shows, movies and other types of work should be treated in the same way whether cited as a printed version or an online version. You can also use the name of a publishing organization when a web page does not have a listed author, but is associated with a corporation, association or professional group. When the author of a web page cannot be identified and there is no clear publishing organization, just list the title first. Use the first letter of the first word in the title, which is not an article (i.e. a, a or a) to determine the alphabetical order of the record in the bibliography. For example, if the title page is a guide to baking apple pies, G should be considered as the first letter for the purposes of alphabetization. Dates for Web Sources: If the source you are referring to has a clear publication date, use it as a source date, following standard guidelines. Otherwise, look for a review date; many websites will make a note when they were last changed, edited or revised. If you use the revision date, not the publication date, if you have made it clear: The last one changed on May 17, 2019. You can use both on your own, in which case you must distinguish two: Published April 26, 2019; last changed on May 17, 2019. If the date is not available at all, use the date you accessed the source to Data: Available August 7, 2019. Access to October 27, 2017. . Blog titles should be installed in italics and blog entries should be set in guotes. Typically, blog posts are only given as notes. If you often guote a blog, however, then you can include it in the bibliography. Note: if the word blog is included in the blog name, there is no need to repeat it in brackets after that title. N: Social media posts on social media are often cited only as notes, although if you intend to discuss the content in detail, you should also put a quote in the bibliography. Since it's easy - and shared - for social media posts to disappear with little notice, it's advisable to take a screenshot or similar recordings of everything you're going to cite, so future edits or deletions won't undermine your job. Please note that all this applies only to public content on social networks. Private content, such as a direct message or a message in a group with a limited membership, should be cited as a personal message. Social media posts usually don't have names, so if the name isn't provided, just use the text of the post, keeping all the original capitalization, spelling, etc., set in Roman with quotes. Do not include more than 160 characters in this quote section; if the post is longer, cut it (with an ellipse) to a reasonable point before the 160-character mark is reached. The citation of a post on social networks should correspond to the following format: N: 1. Ideally, the post should be quoted by the author's legal name and the name of the screen/internet handle, but if there is no screen name (such as a Facebook post) or no legal name is available (such as on a Twitter post), use depending on whether you have one. Also note that you don't need to include a format/medium if the message is just text and you should only include a time stamp if it is relevant to your point or need to distinguish multiple quotes on the same day.
