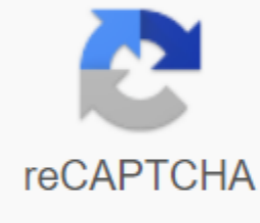

## Brazoria county criminal records online

Classes print feedback information such as: number of reasons, hearing dates, fee and action information on criminal misdemeanor cases can be found online on our Brazoria County Judicial Record Search website. If you don't have the case number, change the search word to Defendant, enter your name (last name, first name), and click search. Find the case and take into account the cause number (if you call the office, you will need this number, we will not answer questions without a reason number), and then click on the case number to view the case information. You can locate the trial date, time & judge according to events & orders of the court. The county clerk's office does not specify a hearing or court date. In order to set a date for the court, please call the office of the Court coordinator to the appropriate court. The Texas Department of Public Safety compiles and manages statistical crime figures for cities and counties. According to data released in 2017, 1,263 crimes were recorded in the county. Theft-theft was the most common crime, with 684 reported while assault was the most common violent crime. Compared to data published in 2016, the total crime increased by 0.9 percent. The number of burglaries increased from 270 to 303, while the number of theft cases increased by 5. In contrast, the number of robberies and assaults decreased between both years. Criminal Records Residents can receive public police reports from contacting police in the city. Box 4143 Austin, TX 78765 The department maintains an online conviction database with various types of public data, including Class B misdemeanors, convictions, prosecutions, and arrests. Members of the public can use an online platform to search for criminal records. In addition, the Texas Department of Public Safety (DPS), provides online access to state-level sex offender records. County residents can search for registrants by name. Searches can also be filtered to reveal offenders within a map address or those enrolled or working in higher education institutions. The public registry is also available as a downloadable file for users who want to run statistics or perform other actions. How to obtain inmate information about persons currently held at state correctional inmate facilities can be obtained by contacting the Texas Department of Criminal Justice (TDCJ). It is an online search service that stakeholders can use to locate inmates. Searches can be performed using the owner's name, SID (state identification) number, or TDCJ number. Court records brazoria county court system consists of several district courts, constitutional courts, county courts of law, judicial courts, and municipal courts. Each of these courts has different jurisdictions in different cases. District courts have general jurisdiction in civil and criminal matters. Constitutional courts have jurisdiction in most probate cases. They also share jurisdiction in judicial courts in civil cases, where the amount of the dispute is up to \$10,000. City courts have exclusive jurisdiction over infringements of regulations. Cases relating to infringements are also being heard. In order to use the service, applicants must provide their contact details, social security number, date of birth and the period range sought. In addition to district courts and courts, Brazoria County is home to several municipal courts that have exclusive jurisdiction over regulation violations as well as cases involving misdemeanors. Residents can find court records by visiting the court where the case was heard. Locust, Ste. 500, Angleton. The agency processes applications for walk-in applications on the same day. Residents can also receive copies of an email request sent to: Brazoria County District Clerk, 111 E. Locust, Ste. 500, Angleton, TX 77515 Walk-in or mail applications must include the case number as well as specify the number of copies requested. They must also provide a valid government-issued id and contact details from the requesters. Divorce Checks Acquisition The Texas Department of State Health Vital Statistics Unit maintains records divorces in Brazoria County and other parts of the state. However, it only checks the divorce, not a copy of the actual order. Box 12040 Austin, TX 78711-2040 The class charges a fee of \$20.00 for divorce checks. Applications must include the date of divorce, the names of the spouses at the time of the divorce and the applicant's contact details. How to obtain birth/death records The Brazoria County Clerk's Office issues copies of birth and death certificate events that occurred in the county. In order to obtain the register, applicants must be either the person, child, sibling, grandparent, spouse or legal guardian named on the register. Applications must include a valid government or state-issued image id. In order to obtain the registers by post, the applicant must submit a completed birth/death registration application form. The bureau is asking for \$23.00 for each certified copy of the birth certificate. The mortality figures cost \$21 for the first certified specimen and \$4.00 for each additional copy. Applicants shall also provide proof of identification in order to establish their relationship. In addition, the Texas Department of State Health Services processes requests for births and deaths records from 1903 to the present day.
