

Manuscript Submission Guidelines: Multiple Sclerosis Magazine This magazine is a member of the Ethics Committee of publishing. This journal recommends that authors follow the guidelines for the conduct, reporting, editing and publication of scientific work in medical journals, formulated by the International Committee of Medical Journal Editors (ICMJE). Please read the guidelines below and then visit the magazine's submission site to download the manuscript. Please note that manuscripts that do not comply with these recommendations may be returned. Only sufficient-quality manuscripts that meet the goals and scale of the multiple sclerosis journal will be considered. There are no fees to be sent or published in this journal. As part of the submission process, you will need to ensure that you submit your original work, that you have rights in the work, and that you have obtained and can provide all necessary permissions to reproduce any copyright works not belonging to you, that you submit the work for the first publication in the journal, and that it is not considered for publication elsewhere and has not been published elsewhere. Please see our pre-publishing guidelines and note that the multiple sclerosis journal may accept the materials of documents that have been placed on pre-print servers; please notify the editorial board when filing (contact details are at the end of these guidelines) and include DOI for preprint in the designated field in the manuscript submission system. Authors should not post an updated version of their work on the preprint server while it is being considered for publication in a journal. If the article is accepted for publication, the author may reuse his work in accordance with the journal author's archiving policy. 1. What do we publish? 1.1 Goals and scope before sending the manuscript to the multiple sclerosis journal, please make sure you read the Goals and Scopes. 1.2 Types of articles Please read the following carefully and make sure that your submission meets the requirements to avoid an automatic refund or delay in reviewing your document. All documents submitted by MSJ must submit the author's Declaration form along with your handwritten files before being sent. The form should contain all the signatures of the co-authors. This journal no longer requests traditional or systematic reviews. THE MSJ currently requires authors to provide basic MRI imaging requirements as additional data in order to help replicate the research. When submitting a manuscript using MRI data, please provide the necessary data in a suitable format. Original scientific works scientific papers should be no more than 3,000 words and contain the following sections: Page Title, Abstract, Introduction, Materials (or Patients or or or and methods, results, discussion, confessions, references, tables, legends of drawings, figures (see Sections of the manuscript for more information). Case reports, Short Reports Editors will review for the rapid publication of Case Reports and short reports that illustrate important points. They should not exceed 1000 words in length, must have a front page, a short summary of no more than 100 words, up to 10 links, one digit and one table. Letters to the editor of the Brief Letters are welcome, raising relevant questions concerning recently published articles in the journal Multiple Sclerosis or standalone letters on topics of interest. They will be reviewed and may be sent to the first author of the article under discussion for a possible response. They should be in a letter format without annotation. Autonomous letters on topics of interest, which should be in a letter format without an annotation, will be considered. Personal views that bring new ideas and stimulate discussion and discussion are welcomed by editors, particularly those who will have a common interest, who question or comment on new and significant research related to IPU. They will be reviewed and should be no more than 1500 words, up to 10 links, one digit and one table (if necessary). Current Reviews Topical Reviews focus on specific topics of current interest where there have been recent and significant advances ranging from major neurology to clinical and more applied areas. They are short, factual, targeted updates consisting of: Title page, abstract 100-150 words, 5 or so keywords, 2500 words of text (excluding links), a limited number of relevant and recent links (up to 35 or so), and a figure if appropriate. Disputes in multiple sclerosis disputes focus on current issues, with the contrasting input of leading experts, and cover topics of discussion from basic neuroscience to clinical and more applied areas. Research insights in ... it is a series of short parts that provide clear, concise and simple information in areas that many of us find challenging. They should be no more than 500 words apiece and are presented in a collection of related parts on the same topic (4-6). They must have a front page, a short summary of no more than 100 words (optional), up to 10 links, one digit and one table. Prospects for future perspectives can provide a forum to help capture the work of teams created to improve or update areas that are fundamental to MS, such as clinical and imaging results. Articles will be reviewed and ideally should be no more than 1500 words, up to 10 links, one digit and one table (if necessary). Book reviews and collections These reviews are requested by editors. Note: While editorials, reviews (including book reviews and meetings), and current reviews are usually requested by editors, suggestions on topics or brief outlines of proposals are very welcome and can be directed to the nearest regional editor. Previously published in an un-peer-reviewed format, editors will also consider for the publication of manuscripts containing data already published in the press elsewhere or previously published in an un-peer-reviewed format, such as abstracts or ready-to-camera documents for scientific meetings. The new manuscript should be different from the one previously published and should not contain the same tables or numbers. The senior author will be required to provide the editor with details of previous publications and, if necessary, attach the relevant documents for use by arbitrators. The existence of such an relevant article (s) (published or in the press) should be mentioned as a footnote to the manuscript or documented with the relevant references. The editorial decision will take into account the originality of the work submitted for publication and the extent to which readers of multiple sclerosis magazine may have access to the book or journal in which related articles appeared. Relevant articles published or published in the press may be sent with the manuscript for the editor's attention. MSJ welcomes short reports of zero or negative results as long as the documents are based on strong hypothesis testing. Editorial Policy 2.1 Multiple Sclerosis Journal Review Policy implements the usual policy of a single blind review, in which the reviewer's name is always hidden from the author of the presentation. The documents will be sent for an anonymous review by at least two reviewers who will be either members of the editorial board or others of a similar situation on the ground. In order to shorten the review process and respond quickly to the authors editors can sort submissions and come to a decision without sending the document for external review. The decision of the editorial board is final, and correspondence cannot be entered regarding manuscripts deemed unsuitable for publication in the journal Multiple Sclerosis. All correspondence, including notification of the editorial decision and requests for review, will be sent by email. 2.2 Copyright documents should not be submitted for consideration until all authors have obtained consent. Those submitting documents should carefully check whether all those whose work contributed to the work on the document were recognized as sponsors. The list of authors should include all those who can legally claim the authorship. These are all those who have made a significant contribution to the concept or design of the work; or the acquisition, analysis or interpretation of data, drafted article or revised critically for important intellectual content. Approved version to be published, Each author had to take a sufficient part in the work to take public responsibility for the relevant parts of the content. The authors must comply with the terms of all of the above points. When a large, multicenter team has done the work, the team must identify those who take direct responsibility for the manuscript. These individuals must be fully compliant Authorship. Acquisition of funding, data collection or general oversight of the research team is not in themselves authorship, although all participants who do not authorship criteria should be listed in the Confessions section. Please refer to the guidelines of the International Committee of Medical Journal Editors (ICMJE) for more information on authorship. 2.3 Confessions Of All participants who do not meet the authorship criteria must be listed in the Confessions section. Examples of those who may be recognized are those who provided purely technical assistance or the head of the department, who provided only general support. 2.3.1 Third-party representations Where a person who is not listed as an author submits a manuscript on behalf of the author (s), the application must be included in the Manuscript Confession section and in the accompanying cover letter. Statements must: Disclose this type of editorial assistance - including the name of the person, company and entry level Identify any organizations that have paid for this assistance Confirm that the listed authors authorized the submission of their manuscript through a third party and approved any statements or declarations, such as conflicting interests, funding, etc. rather than the authors themselves. 2.3.2 Writing assistance to persons who have provided written assistance, such as from a specialized communications company, is not qualified as authors and should therefore be included in the Confession section. Authors must disclose any written assistance, including the name, company and level of contribution, and determine the organization that paid for it.) It is not necessary to disclose information about the use of language polishing services. Any confirmation must appear first at the end of your article before a declaration of conflicting interests (if applicable), any notes and your links. 2.4 Funding multiple sclerosis magazine requires that all authors recognize their funding in consistent fashion as part of a separate headline. Please visit the Funding Recognition page at SAGE Journal Author Gateway to confirm the confirmation text format in the event of funding, or to find out that: This study has not received any specific grant from any financial institution in the public, commercial or non-profit sectors. 2.5 The Declaration on the Conflicting Interests of the Policy of the Journal of Multiple Sclerosis requires all authors to declare conflicting interests, allowing the statement on the

pages of all published articles. Please make sure that the Declaration of Conflicting Interests is included at the end of the manuscript, after any confessions and prior to the references. If there is no conflict, please declare that the Author (s) declare (s) that there is no conflict of interest. For recommendations on conflict allegations Please see recommendations here. 2.6 Research ethics and patient consent Medical research involving humans should be conducted in accordance with the Helsinki Declaration of the World Medical Association. The manuscripts submitted should comply with ICMJE's recommendations for the conduct, reporting, editing and publication of scientific work in medical journals, and in all documents reporting on animals and/or human studies should be found in the methods section that the relevant Ethics Committee or institutional review board has provided (or refused) to approve. Please make sure that you have provided the full name and establishment of the review committee, in addition to the approval number. With regard to scientific articles, the authors are also required to find out in the method section whether participants provided informed consent and whether consent was written or oral. Information on informed consent to report individual cases or series of cases should be included in the text of the manuscript. A statement is required as to whether the written informed consent to the publication of the information and images by the patient or a legitimately authorized representative was required. Please do not give the actual written informed consent of the patient with your article, as this in itself violates the patient's privacy. The journal asks you to confirm to us, in writing, that you have obtained written informed consent, but the written consent itself must be held by the authors/investigators themselves, for example, in the patient's hospital records. A confirmed email can be downloaded with your view as a separate file. Please also refer to ICMJE's recommendations to protect research participants. All animal studies submitted for publication must be approved by the Ethics Committee, overseeing the agency where the research was conducted. The journal adopted the Guidelines on Animal Ethics and Welfare for Veterinary Journals, published by the International Association of Veterinary Editors. 2.7 The clinical trial journal Multiple Sclerosis complies with ICMJE's requirement that clinical trials be recorded in the WHO-approved state registry of trials at the time or prior to the first enrollment of the patient as a condition for publication. The name of the trial registry and URL, as well as the registration number, must be included at the end of the abstract. 2.8 Reporting guidelines For the relevant GUIDELINES for reporting the EQUATOR network should be followed according to the type of study. For example, all randomized controlled trials submitted for publication should include a completed CONSORT thread chart as a given figure, and a completed control CONSORT should be downloaded with your view as an additional file. Systematic reviews and meta-analyses should include a completed PRISMA flow chart as a given digit and a completed PRISMA PRISMA should be downloaded with your view as an additional file. The EQUATOR master can help you identify the appropriate guidance. Other resources can be found in the NLM Guidelines and Initiatives for Research Reporting. 2.9 Research Data SAGE recognizes the importance of having research data as an integral part of the research and verification process. The Multiple Sclerosis Journal asks all authors to submit any primary data used in their scientific articles along with their articles to be published in the online version of the journal, or to provide detailed information in their articles on how the data can be obtained. This information should include references to third-party data warehouses or detailed contact information for third-party data sources. Data available only on an author-supported website must be uploaded to a log platform or third-party platform to ensure continued availability. Examples of data types include, but are not limited to, statistical files, replication code, text files, audio files, images, videos, applications, and additional diagrams and graphs necessary to understand the initial research. The editor may consider a limited embargo on proprietary data. The editor may also provide exceptions for data that cannot be legally or ethically released. All data submitted must meet the requirements of the Institutional or Ethical Review Board and applicable government regulations. Preparing the manuscript to send 4.1 Formatting Preferred format for Word manuscript. LaTeX files are also accepted. Word and (La)Tex templates are available on the Manuscript Submission page of our Author's Gateway. Preparing the manuscript: Sending a new manuscript through an online system: When submitting an application, the following separate, unprinted documents should be downloaded. Please do not send one combined document. Individual files will be merged into a pdf in an online system. Title page (title, authors' names, affiliations, keywords, corresponding author) Main document (includes structured abstract, basic text, confessions, links) Tables (each in the form of a separate Word document) Drawing legend (Word document) Figures (as a separate tiff, jpg or eps files) Any additional files Sending changes: After reviewing editors can offer a presentation of the revised manuscript. When you submit a change, remove the original files (as they are stored with the original view) and download only the revised manuscript in accordance with the usual submission guidelines. Changes in the manuscript should be noted using a selection or changes, and the authors' response to reviewers' comments should be placed in the appropriate box during the submission process. The text must be double throughout and with a minimum of 3 cm for the left and right hands and 5 cm in the head and leg. The text should be a standard 10 or 12 points.
