

This means that around 2% of international students have remained in the UK under Tier 2 (General) visa sponsorship. However, let's not forget that of the 319,000 non-EU students most do not want to stay in the UK after studying and do not actively apply for Level 2 jobs. This article covers: Tier 2 visa criteria, however, are strict, and include the basic requirement to have a genuine job offer from a licensed sponsor. The Home Office maintains a list of Level 2 sponsors, called the Register of Licensed Sponsors, which details all UK employers who have a valid sponsorship licence allowing them to hire skilled workers who are not members of the EEA. For applicants, the Level 2 sponsorship list can be a useful resource to help focus job search in the UK for licensed employers. What is a Level 2 sponsor list? The Level 2 sponsorship list is a published entry of organizations licensed to sponsor non-EEA migrant workers under a system based on levels 2 and 5. He is entitled Home Office Sponsors Register Licensed under a Points-Based System. The list is updated on a regular basis. It currently shows more than 27,000 sponsors registered under tier 2, with more than 29,000 total including Tier 5 sponsors. What are the category of Level 2 sponsor lists? The list of Level 2 sponsors includes information on the category of employees, employees, The employee has a sponsorship license and their sponsor can be licensed under more than one level, and can have different ratings for each level. There are four categories under the Level 2 Sponsor's License route: Tier 2 (General) - so that non-EEA nationals can accept a job offer that cannot be filled by a properly qualified or qualified sedentary worker. This includes workers coming to the UK to fill a shortage of occupations, that is; there are not enough workers in the domestic labour market to meet demand. Tier 2 (Intra-Company Transfer (ICT) - in order to ensure that existing employees who are not EEA citizens are transferred to a branch in the UK. Level 2 (athlete): in order for elite athletes and coaches who are an international base to be based in the UK. Level 2 (Minister of Religion): So that religious workers can work in the religious community in the UK. Most sponsors from the Level 2 sponsorship list are licensed according to Tier 2 (General). Under this level, employers are required to advertise any work offered to non-EEA migrant workers unless it is included in the list of occupations not on the list of non-listed persons and that there is no such thing as a requirement of non-EEA employment in the UK. What are the ratings of the Level 2 sponsor list? For each organization included in the list of sponsors of Level 2, there is a sponsorship rating. A sponsor's license can be rated as 'A' or 'B'. The Home Office will only grant a licence to those who can achieve an A-rating, i.e. the employer has effective human resources systems to be able to carry out their sponsorship duties. Once a Level 2 sponsor's license has been issued, if the Home Office finds evidence that the organization cannot or does not wish to continue to perform its sponsorship duties, or there is evidence of non-compliance with immigration law, this may result in a downgrade to the 'B' rating, or the suspension of the sponsor's license, or in the most severe cases, cancellation. If your sponsorship card will be revoked and you may have to leave the UK. How best to use the Tier 2 Sponsors List of Tier 2 sponsors can help you find a suitable sponsor employer based on the following information: the name of the organization (in alphabetical order) city / or county level and rank rating, such as Tier 2 (General). When looking to identify sponsor employers, you should create a list of organizations from a List of Level 2 sponsors that is related to your industry. You can then search each organization using job search websites to identify those who are currently advertising vacancies. You will need to make sure that any advertised work is consistent with Level 2 skills and salary levels. To obtain a Tier 2 (General) visa, work usually has to be Level 6 or higher gualifications (RSF). In most cases, the minimum wage requirement is at least 20,800 pounds per year for new entrants or 30,000 pounds for experienced workers or the corresponding rate for a particular job offered, whichever

is higher. Appropriate rates of remuneration for each profession are set in accordance with the Codes of Practice for Skilled Work in accordance with the Immigration Rules (table 2 - Professions qualified under the Framework Regulated Skills (RFF) Level 6 and above). Other Tier 2 Visa Requirements In addition to a job offer from a licensed Level 2 sponsor to be eligible for a Tier 2 visa, which you will need to show: - a valid sponsorship certificate for this work appointed by your sponsor; Proof of your English language skills - certificate of personal savings to feed yourself upon arrival in the UK. You can prove your English as the United States, Canada, and New York. To prove the service criteria, you will need to provide a bank or building company with a statement of 190 days before applying. In addition, if your sponsor can guarantee support that meets this requirement, this should be shown on your sponsorship certificate. When applying for a tier 2 (General) visa, you will also need to provide a current passport or travel document to prove that you can travel, along with expired passports or travel documents, if you need them to show your travel history. If you are going to work in education, health and social care in the UK, you will need a oriminal record certificate. Should I seek legal advice when applying for a tier 2 visa? To do a qualified job in the UK, you will need an offer of relevant work, as well as a sponsorship certificate awarded from an organization from the List of Level 2 Sponsors. You will then need to apply for a Tier 2 visa so that you can legally take up work in the UK. Immigration rules can be complex and constantly changing.
