United States citizens must obtain a Canadian work permit to take a job in Canada. However, compared to citizens of other foreign countries, United States citizens have a relatively fast and simple process of obtaining a work permit. For example, United States citizens are not required to obtain a temporary residence visa to enter Canada, which saves time and money. Not all professions in Canada require a work permit. For example, clergy, emergency medical services, judges and athletes are only a handful of professionals who can work in Canada without one obtaining a permit. To determine if your line of work waives your work permit requirement, you should consult Citizenship and Immigration Canada for a published list. Before you obtain a work permit in Canada, you must first have an employment offer from a Canadian company. In addition to a written letter from your employer, you must also provide evidence proving your qualifications for the job. For example, if a company in Toronto wants to hire you as an electrical engineer, you must provide educational or professional documents proving your qualifications. The application for a work permit is quite brief by immigration standards. It is two pages long and written in French and English; two official languages of Canada. There is also a separate form if you decide to apply for a work permit with the help of an immigration lawyer. The content of the work permit application is simple and address personal background, employment information and previous immigration history to Canada. Applications for work permits are submitted on a regional basis. If already in Canada, there are three CIC offices that accept the majority of applications: Vegreville, Mississauga and Sydney. By signing I-134, you agree to financially support a foreign guest during his stay in the United States. This article will provide information to help you in filling out Form I-134 to help foreign visitors applying for tourist or other nonimmigrant visas. If you are a U.S. citizen who will have to submit Form I-134 together as part of a K visa application for a foreign fiancé, you can find more specific tips on filling out form I-134 for the fiancé visa. Or, if you sponsor a relative for a green card, you can find useful information on filling out Form I-864, an affidavit of support under Section 213A of the Act. Who must submit Form I-134 Under U.S. immigration law, noncitizens traveling to the United States are inadmissible if, among other things, they are likely to become a public charge. This means that if they cannot show that they have enough money to pay for their expenses (e.g. food, accommodation, transportation, and any emergency medical care), they will not be able to obtain a visa at the U.S. Embassy or Consulate or may be denied entry at the border if they are in relation to the U.S. Visa Waiver Program (VWP). However, noncitizens can overcome this finding if a legally admitted U.S. resident or U.S. citizen prepares Form I-134 for them to show up at an interview at the U.S. Consulate or customs and border protection (CBP) official upon entering the U.S. What are the risks of sending an I-134 form? When you complete and sign I-134, you assure the U.S. government that the non-immigrant person you sponsor should not seek government assistance such as Security Income (SSI), Temporary Assistance to Needy Families (TANF), Food Stamps or any other government-subsidized benefits. If your foreign visitor ends up applying and getting government assistance, help, a responsible government agency may take into account your income and/or assets when deciding whether to grant benefits. In addition, the government may sue you to reimburse the cost of providing state assistance to your relative. However, a temporary support affidavit on Form I-134 is often referred to by legal experts as unenforceable, especially compared to its longer-lasting counterpart, Form I-864, which U.S. citizens and permanent residents submit when sponsoring foreign relatives for a green card. There are several reasons why I-134 is called unenforceable: Visitors to the U.S. are not eligible for the vast majority of government-sponsored government aid benefits in the first place, and if they apply, they will in most cases be denied. Most government agencies do not have the time or resources to enforce the terms of I-134, even if a temporary visitor does get government assistance. Sponsor I-134 agrees to maintain a nonimmigrant period only for a limited and specific period of time, so any potential liability is limited to the scheduled duration of the visit. In other words, the shape of I-134 is a bark, not a bite, from a legal point of view. It is mainly used to show immigration officials that an otherwise indigent noncitizen has a friend in the U.S. earning a respectable income who is willing to take care of him or her. Preparation form I-134 Form I-134 and instructions are available on the I-134 page of the USCIS website (www.uscis.gov). There is no fee to file this form. These instructions apply to the form version of 13.13.2019, which expires on 28.02.2021. Part 1: Information about you (Sponsor) You, as a sponsor of a person coming to the U.S., will be asked to provide information about your bank accounts, assets, employment and other financial resources. You must show that your income is at least 100% of the amounts listed in the federal Poverty Guidelines for your family size and your state of residence. Issues 1-7: Fill out your name, past names (e.g. before marriage), mailing and physical address, and date and place of birth. Issue 8: If you are a green card holder, you have a foreigner registration number (number) here. Issue 9: Enter your valid Social Security number. Issue 10: You will have an online USCIS account number online if you come to the U.S. as an immigrant and have registered for such an account during the application process. Don't worry if you don't have one. Issues 11-12: If you are anything other than a U.S. citizen by birth, you will need to provide more information here. If you have obtained U.S. citizenship through naturalization, from your parents, through qualifying or by any other means, list the requested information here. If you are a legal permanent resident, your number is on your green card. If you don't have enough income, then you should be more diligent about transferring a lot of assets to show that you have property value that can be used to support your non-citizen visitor. If you are unemployed or low-income, consider another person full form I-134, if any. If you list personal property, you can give an approximate value of vehicles, jewelry, appliances and any other assets that you would like the government to take into account. For real estate, you can use valuation services such as zillow (which are not fully reliable) or hire a professional appraiser. 10-37: Provide information for all dependents you have listed on your U.S. federal tax return. If you are a non-resident who pays taxes abroad, you must list any minor children or adults for whom you have been appointed guardian. The U.S. government also wants to know if you have sponsored any other noncitizens in the past and if you are still required to support them. List all noncitizens for whom you have completed Form I-134 or Form I-864. The U.S. Embassy or Consulate will consider whether you financially support all non-citizens that you sponsored. Documents to attach to Form I-134 you must attach evidence to show your income. In most cases, this will be enough to provide a copy of your latest federal form of income tax (or tax transcript), but you can also include a letter from your employer and your bank to confirm your work and money for a deposit in U.S. bank accounts. Make sure to provide two copies of any documentation you send with Form I-134 (and keep a copy for your own records). Here's some evidence others have used to successfully show that they are able to support a non-citizen visitor: Evidence of recent federal tax returns. The best proof is the IRS tax transcript, the official summary of your tax return. Information about ordering a tax transcript can be found on the IRS website, but if you are in crisis time, you can provide a personal copy of your signed tax return. Copies of government declarations are not necessary. Employer's letter. This would ideally be on the company's official form and written and signed by a human resources officer or your boss or employer. Make sure it includes a recent date, hiring date and length of work, the nature of your job, (if your job is full-time and permanent, make sure he or she makes a note of that!), and your annual salary. A letter from financial institutions confirming the accounts. You must ask any banks or other financial institutions that you have listed previously to confirm your account, letter on the official form. If your average balance is much lower than your current balance, it may look suspicious, so you can ask the bank bank your average balance from the letter, if that's the case.
