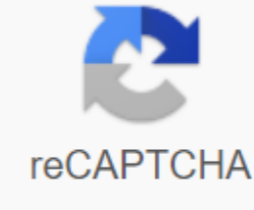

The work may address the issues discussed in JEP: Learning, Memory and Cognition, JEP: Human Perception and Performance, JEP: Animal Behavior Processes, or JEP: Applied, but may also address issues in other subdisciplinary psychology, including social processes, developmental processes, psychopathology, neurology, or computational modeling. Articles in JEP: Common may be larger than a regular magazine publication if necessary. Brief reports will also be accepted (up to 3,000 words, except for the title, reference, author affiliation, recognition, figures and figures of the legend, but including abstract). Brief reports tend to be rejected without consideration by editors at a higher rate than longer articles, and the journal will accept only the most innovative and significant empirical and theoretical contributions, with a preference for work that affects more than one area of psychology and, for empirical contributions, demonstrates high reliability of results. If possible, the journal evaluates the replication and expansion of key results in the article as an excellent means of demonstrating the credibility and overall result. Internal reproduction is encouraged even for brief reports through brief reporting and/or the use of electronic supplementary materials. Replication articles will only be published online and will be listed in the content table in the printed journal. If the authors want to do this for consideration to facilitate readability, they can include tables, figures and legends of figures as needed in a manuscript close to where they will appear in the published article. This information (2-4 sentences) should be provided as part of the author's Note. The authors of the accepted manuscripts are required to transfer the copyright of the APA. Ethical Principles This is a violation of the ethical principles of the APA publish as raw data data that has been previously published (Standard 8.13). In addition, the APA's ethical principles state that, after the results of the studies are published, psychologists have not withheld the data on which their findings are based, from other competent professionals who seek to verify the main claims through re-analysis and who intend to use such data only for this purpose, provided that the confidentiality of the participants can be protected and if the legal rights relating to proprietary data do not exclude their release (Standard 8.14). The APA expects the authors to adhere to these standards. In particular, the APA expects the authors to have their data throughout the editorial review process and for at least 5 years after the publication date. Authors are required to learn in writing that they have complied with APA's ethical standards in treating their sample, person or animal, or describe the details of the treatment.
