Detailed instructions and forms are provided in the CDA Renewal Procedures Guide. Apply to renew the CDA. Once you have met all the requirements, you are ready to complete and submit your CDA renewal application. To apply for cda renewal online the fee is \$125 and to apply for cda renewal by mail the fee is \$150. Remember: You can submit your CDA renewal application just six months before the cda credential expiration date. If you are applying for pre-school, infant/infant or family childcare, we recommend that you apply for cda renewal online. You will be able to upload your documents directly to your online application, submit the payment online, track your progress and contact the Council through the Messages function. You can also renew your CDA credentials by sending a printed application. If you apply on paper, please post a full Renewal Request with the required documents and payment to: Professional Recognition Board 2460 16th St. NW, Washington, D.C. 20009-3547 After receiving the application, full payment and supporting documents, Council staff will review the materials to make a certification decision. If the materials are incomplete or do not meet the requirements, the Council shall inform the CDA renewal candidate and shall be given the opportunity to resolve the problem within a specified period of time. NOTE: You must renew your CDA credentials before it expires. All CDA credentials awarded on or after 1 July 2013 are valid for three years from the date of award. Since you can submit your CDA renewal application just six months before the expiration date of your credentials, be sure to prepare in advance and be ready to submit a full application with supporting documents when the renewal window opens. The preparation and documentation of the members' documentation and the documentation of membership should not be submitted to the Council. Instead, you should select an Auditor to check the training and membership documentation. Select a staff member within the center/program who has the authority to review your training record. The Auditor may be a training coordinator, centre manager, assistant manager or other authorised staff person. The ECE reviewer can also serve as Verifier. The Auditor submits the verification via a link sent in the request e-mail message. If a paper application is submitted, the Auditor shall complete and sign Section E of the CDA renewal application®. No other documents must be submitted. Vocational development is one of the requirements, and can be met with a 45 hour training clock in pre-school education and/or child Development. Do continuous pre-school education courses count for CDA renewal? Yes! There are four types of CDA credentials as shown below with their descriptions: Preschool training content should be specific to preschoolers (3-5 years old) in a central setting. The content of infant-toddler training should be specific to infants and toddlers (birth-36 months) in a central environment. The family content of Child Care Training should be specific to children between the ages of 5 in a family childcare environment. Home Visitor* All courses must be in family systems, adult education, home visit, case management, early education, and/or child development, etc. * Although the information in some of our ECE courses may be related to guests at home, we do not offer a CDA renewal package specifically for home visitors at this time. Since 4.5 CEUs or 45 hours of clock are required to renew the CDA, CDA renewal packages are easily grouped into a five-part series, which includes Part A to Part E. Each part consists of nine hours of self-study for a total of 45 hours of clocking. Tasks can be completed in any order, and it is recommended to write only one part at a time. Select the CDA refresh package on the CDA refresh page, or use the Theme filter in the Library Course Version menu. CDA Family Renewal CDA Infant Renewal-Toddler CDA Preschool Renewal your main interest renews CDA credentials instead of gaining professional development for your registry requirements, select All States from the State Approvals menu in the library, and select the relevant CDA refresh type from the Theme menu. If you are looking for courses that meet both the renewal needs of the CDA and your needs in the state registry, select your status using the state and select the relevant CDA refresh type with the Theme filter. How is education verified? You will receive a certificate of completion for each of the five parties after the success of the examinations in this section. The

completion certificate lists all the required components for the CDA refresh documentation. You will NOT receive a final certificate after all 45 hours have been completed. Instead, you'll use the five certificates from the five-part series to verify your training. Does continuing pre-school education report the completion of courses to the CDA Council? The individual holder of CDA credentials shall be responsible for verifying training with the Board when submitting renewal documents. More information is available in the CDA Council Renewal Guides. Training organisations, such as continuity, do not report training to the Council.
