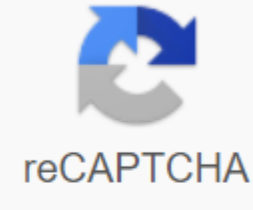

By WAFB staff December 23, 2013 at 6:55pm CST - Updated July 2 at 8:10 AM BATON ROUGE, LA (WAFB) - A Baton Rouge man is accused of being combative with soldiers after being taken into custody on suspicion of drink-driving. During the booking process, he got a further charge after allegedly spitting at prison officers and making threatening statements. According to the probable cause report, the accident occurred just before 4:00 a.m. on Friday, December 20. A Louisiana State Police trooper has started a traffic stop after witnessing a vehicle driving at high speed along River Road in downtown Baton Rouge. I couldn't block the speed of the vehicle... yet, as he tried to reach the truck (with lights and sirens activated) my patrol vehicle was traveling at 85 mph and the vehicle was still moving away, the soldier noted in the report. As soon as the vehicle stopped, the driver... jumped out of the truck and approached me aggressively. The driver, Brian Hartwell, 25, allegedly admitted to drinking, but refused to take a field sobriety test or submit to a breathalyzer. I asked Mr Hartwell if he had anything to drink tonight, who replied 'I only had six drinks tonight, my manager can check it out.' Hartwell is said to have become verbally abusive at this point and uttered several swearing at the officer. At this

point he was put under arrest. Mr. Hartwell continued to act belligerently by slamming the chair against the wall, picking it up and slamming it to the ground, the soldier noted about the booking process. While trying to subdue the subject, he attempted to lash out at the officers. In a report presented by the of the East Baton Rouge Parish Sheriffs Office, Hartwell would threaten prison officers by saying, If I put up these handcuffs, I'm going to make a deputy. The deputy claims Hartwell spat in his face when he was escorted into a cell. Cell. he is charged with DWI (third offense), reckless operation, disobedience to the red light, driving in suspension for previous offenses, simple criminal damage to property, and battery on a prison officer. His bond is set at \$17,100. Hartwell was previously arrested for DWI on August 18, 2013 and again on November 3, 2013 according to booking reports from EBR Parish Prison. Reports.
