IKEA’s return policy at U.S. stores is simple: You can return furniture, home furnishings and anything non-customizable (like cut cloth and counter tops) or items with receipts within 90 days for a full refund. You can also return mattresses within 90 days, but you can only redeem them for store credit [source: IKEA]. (Be ready to present your receipt and identities with your return, a measure to limit return fraud.) It’s rarely OK to bring furniture back that’s stained, scratched or broken unless those are symptoms of a defect, and sullied mattresses certainly can’t be exchanged. But if you’re returning something half assembled and out of its packaging, don’t worry - returning it that way isn’t polite at all. About Ikea Refund Policy The Ikea Refund Policy states that you can return any items purchased from them within 365 days of purchase. They will provide you with a full refund if you return the product in an unspersed state with the original receipt (or any other proof of purchase). If you change your mind and return the goods within 14 days of receiving the goods, Ikea will also refund your delivery fee. If the return criteria are not fully met, Ikea may refuse to return or provide you with an exchange or Gift Card, depending on the severity of the reason for the return. This means that any Items you purchase from them can be returned if it is eligible under Ikea’s return policy. The three options available to you are: Return at the store, Return at The Point of Collection or Return online by CollectPlus. But before returning your goods make sure it is eligible for return under the Ikea return policy. Return your in-store items To return your goods at any Ikea store, follow these steps: Find your nearest Ikea store. Pick up your goods to be returned with the original purchase receipt (or any other proof of purchase) along with the original packaging. When approached, Ikea customer service will help you in the return process. You will get a refund immediately when you return to the store. Refunds will be provided as an initial payment (the payment method you used while purchasing the items). If you choose an exchange, Ikea will only be able to provide you with the exchange if the requested items are available in stock. Go back at any Collecting point. Ikea currently has three collection points; the first was at Westfield Stratford City, and 2nd & 3rd in Norwich and Aberdeen. Collection points are an innovative way to improve your shopping experience. The return process at the Ikea collection point is the same as returning the goods at the Ikea store. Return by Mail If you do not have time to return the item by visiting the store or collection, then Ikea in partnership with CollectPlus gives you an option through which you can return the item by Mail. Print the CollectPlus label at home or at the CollectPlus store by visiting this page. Attach the label to pack and Send it via CollectPlus. After Ikea receives your return, they will start a refund. Returns are not received As of now, not much information is available for declarations not received at Ikea. If you buy an item online then you can print out the order confirmation at any time. Besides, if you make a purchase from an Ikea store and lose your receipt, you should contact customer service. They will assist you with other options available. So, as far as we know, the Ikea will not accept returns without receipts. In this case, you will be refunded in the form of store credit. The value of refunds will be the least selling price of the items. The Ikea refund policy will immediately provide you with a refund if you return an order to any Ikea store. If you return the items online, it may take 3 to 4 business days to process your refund. Moreover, it can take up to 10 business days for the amount to be reflected in your bank account. To return Smaller Items Online (with a weight of less than 10 kg normally) can be returned by FedEx or UPS. To return the goods, you must place this form in the package along with the goods and shipping invoices. Other steps are similar to this section.
