A matter of privacylt complete information about Williams' property plan is not known, but recently, a website got hold of the trust document for its children and published it, according to Investment News. Trusts are favored among the rich and famous because they ensure that the creator's wishes for the estate are carried out away from the public eye. Unlike one will, a trust typically does not go through probate and is not published by the courts. So how was this particular trust published? Investment News states that it happened because a lawyer applied to the courts for a new co-trustee after the original had died in 2008. Had the trust stated that a lawyer or other person had the power to name a successor administrator, the trust would probably have been private. The two quickly bonded and became close friends. The pair were seen out and about Hollywood and were immediately inseparable. In 2005, Williams met actor Heath Ledger while filming the film Brokeback Mountain. The two began dating and on October 28, 2005, Williams gave birth to the couple's daughter, Matilda. The couple named Philipps as their daughter's Godmother and fellow Brokeback Mountain star Jake Gyllenhaal as the child's Godfather. Philipps was there for her friend when she needed her most Williams and Ledger dated for another year after the birth of their daughter, but in the end, the couple chose to go their own way. The two continued to coparent their daughter and remained close friends. In 2008, tragedy struck when Heath Ledger was found dead in his New York apartment. The actor had died of an overdose. Williams and her daughter were flying to New York when they heard the news of Ledger's death. Although the two were separated, Williams was devastated by the news. Philipps stopped everything to be by her best friend's side in her time of need. Philipps later admitted that she thought Williams and Ledger would end up together again, but unfortunately they never got the chance. During an interview with People magazine in 2016, Williams opened up about her best friend. She told the magazine, referring to Philipps, I'm so in love with her. Philipps recalled the first time she met Williams and said it felt very high stakes, referring to the fact that they had each been told they would love each other. But at the time of his death, he was near bankruptcy and reportedly worth about \$50 million due to multiple divorces. Divorce is expensive, Williams, who was married to his third wife at the time of his death, explained Parade Magazine. I used to joke they would call it 'all the money,' but they changed it to 'alimony.' It's tearing your heart out through your wallet. Robin was survived by his three children: Zachary, 31, Zelda, 25, and Cody, 22, as well as third wife Susan Schneider Williams and her two teenage children from a previous marriage. He set up trust funds for his children TMZ reported that Robin set up trust funds for all three of his children. The trust documents stated that each child would receive one-third of the proportion at the age of 21, half of what was left at 25, and their full share of 30. It wasn't dependent on Robin's death. Zachary has received his money in full, while Cody and Zelda have each received payment based on their age of 30. Each of the children issued a statement after Robin's death that conveyed how much their father meant to them. Yesterday I lost my father and a best friend and the world got a little gray, began the statement from Zak Williams. He's the only child from Robin's first marriage to Valerie Velardi. Cody Williams, one of two children from Robin's second marriage to Marsha Garces, said: The world will never be the same without him. His daughter Zelda's statement touched the hearts of many fans and showed her love for her late father. Dad was, is and always will be one of the kindest, most generous, gentlest souls I've ever known, and while there are few things I know for sure right now, one of them is that not just my world, but the whole world is forever a little darker, less colorful and less full of laughter in his absence. Still, Robin's death proved stressful for his children, who found themselves embroiled in a fight over his \$100 million estate with wife Susan Schneider Williams. Robin took his own life in August 2014. In December, court documents revealed that Schneider Williams and the three children were involved in a dispute over the money and property left to them. Both sides revealed their interest in keeping memorabilia such as Robin's bicycles, collections of fossils, and photographs. The biggest asset at stake was the \$100 million home that Robin left to his children on the condition that his wife was taken care of. The two parties ultimately settled allowing Schneider Williams only a fraction of the estate, which should be sufficient to allow her to remain in the home for her lifetime. She was also allowed to keep the emotional things she requested, including their wedding gifts, a watch, and the bike they bought together on their honeymoon. His children retained Robin's awards, including his Good Will Hunting Best Supporting Actor Academy Award, six Golden Globes, two Emmys, and five Grammys, as well as the majority of the estate.
