A 12-year-old victim was raped inside a Mexican state pickup truck, just feet from her home. While the reason behind the massive number of child sexual assaults committed by illegal aliens is being ignored by the public press, there is a fairly simple (and sickening) explanation for the epidemic..... Fifteen-year-old girls have a ceremony called Quinceañera, which announces their availability to become wives, mothers and girlfriends. In America, children of this age are expected to finish another three years in high school, which followed, hopefully, a college education. But in Mexico, young girls are considered available, according to law and the public, immigration expert Brenda Walker wrote in 2007. While most Americans would be shocked by the cultural norms that make this kind of a resentful throughout our neighbor to the South. Put very bluntly, paedophilia is actually protected by many Mexican laws. You see, the age of sexual consent throughout much of Mexico, including its capital, is only 12 years old. Unfortunately, the culture of sex with young girls is brought to this country by many Mexican men, along with their inexpensive, albeit illegal labor, and both real and potential voices. An example of this attitude can be found in the Mexican state of Diego Lopez-Mendez, who pleaded guilty in 2006 to sexually assaulting a 10-year-old West Virginia girl. Through an interpreter he told the court: In pueblo, where I grew up, girls are usually married to a 13-year-old..... I didn't know about the offense character or that it was a bad crime. And given his background, he probably didn't know that sexually assaulting a child was a bad crime. Article 261 of the Mexican Federal Criminal Code states: Who, without sharing, performs sexual activity with a person under the age of 12 years, or a person who does not have the ability to understand the meaning of the act, or that for any reason cannot resist, or demands that the act be carried out, will be punishable by a term of between 2 and 5 years in prison. The age of consent in Mexico is 17 years old. The age of consent is the minimum age at which an individual is considered lawful enough to consent to participation in sexual activities. Persons 16 years of age or younger in Mexico are legally unable to consent to sexual activity and may result in prosecution of statutory rape or equivalent to local law.
