Security (DPS), published in the Official Journal of the Federation (DOF) of December 30, agreement on updating general criteria and relevant formats for the implementation of administrative procedures for training and training employees. The DC-1 format relating to the Report establishing the Joint Training and Training Commission must be maintained by the company in its internal registries, as well as information about the general operating bases and activities of the last 12 months, so that it can be displayed when it is stored by the company in the DC-2 format Presentation of the Training and Training plan and programs must be requisirated and presented at the SBGS within 15 days after conclusion , revision or extension of the collective employment agreement. In the case of companies where there is no collective bargaining agreement, the presentation will be made within the first 60 days of odd years. The procedure can be submitted in a personal form or by means of electronic means on the www.stps.gob.mx website, in which case the secretariat will deliver on the same day the confirmation of the decidious receipt. In the meantime, upon presentation by certified mail or courier services, the receipt confirmation will be sent to the applicant the day after receipt. The DC-2B General Training and Training System format applies to business associations with national representation, which develop general training systems containing modularly structured programs aimed at classes or work of a particular field of economic activity and wish to register them with the secretariat. The DC-3 Consistency of Work Skills format accredits the training an employee receives as a result of approving courses that are part of the company's training plans and programs. Such sustainability is granted to workers within 20 working days from the end of each training courses held in the company. DC-4 format The list of job skills records is used for companies to register in DPS job skills records issued to workers, it must be submitted within 20 working days after ...
