between regulation and leadership. What was recommended in the previous guidance is not necessarily regulation, Grimes said. At first glance, I think this new version does a better job of outlining what the role of a certified medical examiner is. There is a section that sets out what regulation is and what the recommendations are. It also makes clear that regulation is a law they must pass. For example, a section on sleep apnea tells certified medical experts that the agency has no rules specifically regarding this condition. THE FMCSA reminds forensic experts that the agency has no rules or regulations or criteria specifically for screening, testing and treatment of obstructive sleep apnea, in addition to existing requirements in 49 CFR 391.41 (b) (5) and medical advisory criteria of 2000, which are not mandatory, - says the draft guidance of 2019. The new version of the handbook, which has been reduced from about 250 pages to 78, also reminds forensic experts to look for several risk factors because a high BMI alone may not be enough to order a sleep study. The FMCSA Medical Review Board consists of five medical experts who serve two years. The Board is tasked with developing guidelines for certified medical experts in the Department of Transportation Physics. Dr. Gerald E. Harmon, Vice President of Medical Affairs at Tideland Health Group in South Carolina, was recently added to the board He joins Dr. Gina K. Pervall, Dr. Michael T. Kelly, Dr. Brian T. However, with the advent of NRCME, FMCSA has recognized that the Medical Examiner's Handbook contains some outdated information and included guidelines for certain conditions, primarily sleep apnea, that are inconsistent with the current FMCSA guidance. FMCSA removed the Medical Examiner's Handbook from its website and said it would be reviewed. The original project review date was 2015, then 2016, then 2017 In July 2019, the FMCSA Medical Review Board met to review the latest draft of the Manual, which was tasked with reviewing the latest draft draft he made it clear that substantial further review was still needed. It seems doubtful that the revised Handbook will be published in the final form of FMCSA soon. An FMCSA spokesperson confirmed on April 15 that the agency's medical board, which has not met since last summer, will meet April 27-28 in a virtual meeting. The council also plans to discuss progress in the agency's review of its 350-page certified medical expert handbook, which has been in rewriting for the past few years. Another issue the board is set to discuss concerns about the necessary refresher course every five years for medical experts who are still not ready by the agency. The Morris Examiners guide is used as a benchmark for doctors performing medical check-ups for truck and bus drivers, but its proposals are not regulatory in nature. However, the outdated handbook is still used by many physicians for the best management procedures, according to Medical Review Board member Brian Morris, corporate director of medical supervision for Boston-based OccMed Consulting and Injury Care. At a meeting in 2017, the board refused to change the forfeiture policy after discussing a 2007 study that outlined the pitfalls of ensuring that drivers with a history of seizures were qualified to drive. Addressing the takeover requirement, Morris said the current rules automatically disqualify a driver with a seizure diagnosis and require that the driver sometimes a lengthy waiver process, seeking exemption from FMCSA. Tagging that diagnosis on someone can be a career-ender, even if you're doing a great job with medication and not having seizures, Morris said. Morris added: 'It is almost impossible to be granted an exemption waiver. So there is movement in motion to find a way to clear these people to drive.
