(hereinafter referred to as 'AGENT', as the term must, unless the context requires or grants mean and includes its partners at present, their heirs, legal representatives, executors and authorised acquirers) of the second part WHEREAS XYZ Limited is engaged interalia in the marketing industry..... products and are the owners of the trade name and the trademark 'XYZ' WHEREAS XYZ Limited wants to promote products under its trade name and brand name by establishing chain or retail outlets throughout the country, also by designating the most edifying, retailers and franchises for the purpose of setting up retail outlets Whereas the agent has offered to set up such a Retail Outlet in the city.... and has represented XYZ Limited that it is in a position to invest the necessary capital and also holds an appropriate premises to create and continue the Retail Outlet and XYZ Limited has accepted those offers; NOW THIS AGREEMENT TESTIFIES AS FOLLOWS THAT DURING CONSIDERATION OF THE ABOVE, THE COMPANY hereby DESIGNATE M/S as his agent in the city on the following terms and conditions: 1. The retail marketing business products under the name and style of 'XYZ' must be set up and operated in the premises provided by the agent and the premises are more extensively described in the premises'. The premises will be provided free of charge or charges to XYZ Limited by the agent during the maintenance of this Agreement. 2. The agent will meet and bear the total cost of interior and exterior decoration of the schedule-premises in accordance with the specifications and requirements of XYZ Limited, in particular touches on the following aspects - height, décor and décor, selection of furniture, fitting, counters and stands, lighting system, lighting, mannequins, window display, air conditioning, firefighting equipment, furniture, flooring, etc. to be in rs..... The agent at his cost will employ the necessary staff to man and manage the Retail Outlet to the entire satisfaction of XYZ Limited. THE AGENT AGREEMENTS WITH THE COMPANY AS FOLLOWS: 1. It must duly and immediately pay the owner of the Schedule Premises rentals and other charges and keep the lease subsisting and valid and ensure that the Schedule Premises are always available for the operation of the Retail Outlet. 2. That it may not directly or indirectly or in Partnership or Association, with friends or relatives, or companies engaged in business that are the same or similar to those exercised by XYZ Limited. 3. That it may not sell, display or otherwise trade in any goods that are in any way similar to the goods sold or processed by XYZ Limited. 4. That it may not use the Company's trade name and/or trademark in any way other than that permitted by XYZ Limited. 5. That all sales made by the agent are strictly for cash only. 6. That it shall provide XYZ Limited at the intervals by which they required a certified inventory of the stocks of all the goods in his possession and which provide complete and correct information to that effect. 7. It shall send each day all the proceeds of the sale from the previous day to the crediting of XYZ Limited's designated account, which may be declared from time to time and shall immediately send the indication of such transfers to XYZ Limited. 8. That it may not withdraw, accept or approve a bill on behalf of XYZ Limited or in any way pante credit xyz Limited except with the previous written permission of XYZ Limited. 9. It shall at all times be liable to XYZ Limited for any damages arising on the stock, either as a result of the inappropriate or negligent conduct of the agent, its employees or agents or for any reason, and shall make such loss to XYZ Limited when and if they are requested without demur. 10.
