

Announcements in substitute of the act of notoriety - 1. The act of slander relating to states, personal qualities or facts that are directly known to the person concerned shall be replaced by a declaration and signed by a person concerned with compliance with the procedures laid down in Article 30. 2. The declaration made in the specific interest of the declarator may also relate to facts relating to states, personal qualities and other persons of which they have direct knowledge. 3. Without prejudice to exceptions expressly provided by law, in relations with public administration and public service concessionaire, all states, individual qualities and facts clearly indicated in Article 46 shall be certified by the person concerned through the substitute declaration of the Act of Slander. 4. Except where the law expressly provides that the judicial police authority is an essential condition to activate the administrative process for the issue of duplicate of compliant identity documents or in any case to certify the individual properties of the States and data subject matter, loss of documents loss is proven by those who request its duplicates through a substitute declaration, replacement.
