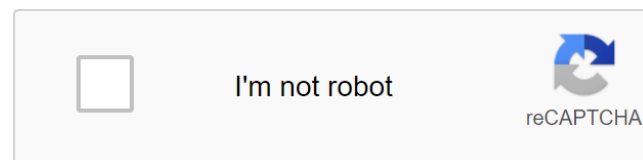

A service officer can assign up to ten non-relationship-related persons and distribute the amounts in ten per cent increments to each person listed.
