Pennsylvania - Venango County Recorder Information The Register & Recorder in Venango County, Pennsylvania is responsible for the registration and maintenance of real estate documents for the county. These records include deeds, staffer and other instruments used in the transportation of property. The registration requirements must be met and fees must be paid before registration can take place. Admission Fees Deed \$86.25 Corrective Deed \$71.25 for a document with four names, three pages, one recognition, and a package. Each additional page over three is \$2, each name over four and each additional package is each 50 cents. A valuation is \$1. Transfer Fee - Franklin or Oil City Property (Deed Only) \$2.00 Agreement on sale, leasing over thirty years, easing, installment land contract, agreement, right to way, modified easing \$58.75 Recorder's seal and certification is \$1.50. Copies of documents are 50 cents per page. If copies are sent they are \$1 per page. State and local realty transfer tax is due upon registration. If you have questions about registration fees or want more information about transfer taxes, please contact the Venango County Recorder at (814) 432-9539. Document formatting requirements 1. A gering must be recognized before The Recorder of Deeds can consider it. Recognition must include the county and the state. The name of the person who recognizes must have exactly the same as the document states. Other necessary items are a notary signature, notary stamp, and notary expiration date. The confirmation date must be on or after the document's execution date. 2. Documents are accepted on 8.5 x 11 inch white paper. Margins should be at least 1-inch and should be free of all markings. 3. A full legal description of immovable property shall be present. 4. The uniform package ID assigned to the package must be specified on the document. Contact the county mapping department for assistance. For a recorded document to provide a constructive notification under Pennsylvania's registration laws, it must have a Uniform Parcel Identifier number. 5. A signed residence certificate with the name and postal address of the beneficiary shall be attached to the deed. 6. A deed should indicate the true treatment of the property or should be accompanied by an original statement of value. If a tax exemption is applied for, the deed accompanied by an original and fully completed declaration of value. 7. Where multiple documents constituting one transaction are submitted, the order of registration shall be clearly indicated. The party submitting the documents is responsible for any re-registration costs resulting from an incorrect registration order. 8. Any corrective documents shall contain a reference to the corrected document and the reasons for rectification. A corrective document shall also contain a statement of value and a registered copy of the document being corrected. 9. A redrawn document shall be re-recognised and shall also contain a grounds for resumption. 10. When a deed relating to immovable property is submitted in more than one municipality, the percentage of the local transfer tax for each municipality shall be indicated. Statement of values: A statement of value is necessary when (1) the full consideration is not stated in the deed, (2) when the deed is free of charge or is by gift, or (3) a tax exemption is required. A statement of values is not required if the transfer is completely exempt from tax based on family circumstances or public supply relief. If the transfer is between family members, the relationship must be indicated on the lap. The statement of values must be completed in full and submitted in duplicate on the grounds of the exemption and the amount of the exemption. A value statement for staff ings and rights must also be submitted in ways. rights in ways.
