The process of applying for an RN license renewal involves providing basic contact information and sending a fee to the state's Board of Nursing or the Department of Health. Some states require RN's to complete further education between each renewal date. In California, for example, each RN must be able to show evidence of at least 30 hours of further education since the last license renewal in order to be renewed again. Nurses who renew their licenses on time receive new licenses in the post and can continue practicing without interruption. Those applying for renewal late may have to pay an additional late renewal fee or, in certain cases, stop practicing until the renewed license arrives.
