Therefore, order belongs to the essence of His church. Order is achieved through principles and regulations that guide the Church in its internal activities and in accomplishing its mission to the world. In order for it to be a successful church organization at the service of God and mankind, it needs order, rules, and discipline. The Bible affirms that everything is done decently and in order (1 Cor. 14:40). Ellen G. White pointed to such needs in 1875: The church of Christ is in constant danger. Satan is seeking to destroy God's people, and one's mind, one's judgment, is not enough to be trusted. Christ wants His followers to gather together in church capacity, obey order, have rules and discipline, and all be treated with one another, respect others better than themselves. -3T 445. But Church leaders did not quickly come up with a book of rules on Church governance, although general conferences met annually during the session in the early years of the Church and delegates voted on issues of church order and life. Finally, in 1882, the General Conference in the session voted to prepare instructions for church officials, printed as a Review and Herald or as a road. -RH, December 26, 1882. This suggests a growing perception that order is required if the organization operates efficiently and consistently in order that its guiding principles must be included in the printed form. However, when the proposal to place the articles in permanent form as a church manual came before the 1883 General Assembly session, delegates rejected the idea. They feared a manual could formalize the Church and take from pastors their personal freedom to deal with orderly issues as they desired.
