Jasmine nunez funeral

New York State Police identified a woman who was found dead and torched in James Baird State Park on June 12, 2011, and said a suspect in the murder also died. State police say the woman who died was tentatively identified as Jasmine Maxine Nunez, 22, of the Bronx. Nunez was last seen with her live-in boyfriend, Andres Cebarjos, 26, police said. Cebarjos committed suicide after fleeing police in Virginia on Monday, the New York State Police said in a press release Tuesday. Over the weekend, Nunez's family reported her missing to The New York City Police Department, state police said. On Monday, Virginia State Police encountered a Cebarjos vehicle, a 2010 Chevrolet Malibu, on Route 58 and headed west to Emporia, Virginia. Southampton County deputies and Virginia State Police tried to stop the vehicle and a chase continued. At one point, Cebarjos left the vehicle and fled. Then he fatally shot himself. New York State Police said a news conference was planned this morning in Valhalla, Westchester County. Lagrange Fire Department firefighters found the burnt remains of a female victim on June 12, 2011, responding to reports of a brush fire just feet from James Baird Park Road. The body, found about 5.m.15 a.m., a mile from Taconic State Park, was believed to have been torched minutes before firefighters arrived, state police said. Days before her body was found in a fire at James Baird State Park, a Bronx woman said she was going to leave her live-in boyfriend, who she described to her sister, Melanie Nunez, 20, as increasingly controlling and always breaking into her Facebook account, emails and phone. Jasmine was planning to leave her boyfriend. The cause of death has not yet been released. Investigations are continuing. All charges are mere charges, and all defendants are presumed innocent unless proven guilty. On her waist were three purple and red flower tattoos surrounded by green leaves. Four days later, only an ambiguous description of a man driving a carFrom the scene at 5:.m a.m. that day, investigators turned to social media to solve the crime. They thought she was alive for Facebook, and state police opened a Facebook page with a photo of the tattoo and asked those who recognized it for help. They offered a reward of \$2,500. Poxo Barracks used its Twitter account to ask members of the public for help: Unidentified victim of murder, possible suspect: facebook page Please help. However, no one came out. A cute, 22-year-old Hispanic woman will lie undying at the Dutch County coroner's office for another four days. Ten days ago, her killer posted a comment on his Facebook page to make it look like he was too busy with college classes to get his phone. It was only when he shot himself after being stuck in traffic by police that her family learned she had actually been dead for more than two weeks. BifFacebook social media virtual cemeteries Both killers and victims left behind tweets, Facebook status updates and LinkedIn resumes. They took their passwords with them when they died, so the accounts are now part of a growing number of virtual cemeteries. That cemetery contains a YouTube video of a woman recording her killer. On Facebook alone, accounts belonging to the dead now reach 30 million by some estimates, and could reach as many as 50 million by 2015, according to the report. These accounts live in Limbo and loved ones are probably locked out forever. This is the story of Jasmine Maxine Nunez and the man who killed her, and their lives and deaths on social media. Warning: Part of this story is graphic, and some readers may find the material upsetting. Melanie Nunez Facebook was her life, says her sister Melanie. She had about 1,200 friends and about 20 photo albums on the network, each with 10 to 15 photos. She was pretty too and everyone tried to get her attention and flirt with her on her Facebook wall. She also had a Twitter account - Princess Jasmine @Caramel_Blend - with 389 followers she updated multiple times a day, in a joking, chatty way. A typical post read: Straighten my curly ass hair. Lumao happy Sunday tho! (She wrote in the last days that she was known to be alive. Andres Cebarjos Melanie Nunez He always surprised her with flowers, says Melanie Nunez. Jasmine had just pulled out of a assertive, young boyfriend-to-be relationship and liked the fact that Ceberjos was more laid back. She wanted to wear pants and she can do it with him, says Melanie. He was 26, four years older than her, so she felt like he was mature and ready to settle down. And the age difference, she felt the need to give him a chance. They'reHappy, they were good. They moved into an apartment in the Bronx together in December 2010. Andres wrote this the day before Jasmine disappeared. Twitter like Jasmine, Andres was also an avid Twitter user. He went with Handled're @YoTeComoEso (I eat it in Spanish). He had 156 followers, half of Jasmine's. His last tweet, sent on the last day Jasmine was known to be alive, #StripperFailタグ付けされ photo of a woman with bruised skin doing a knee dance. Before that day, he asked, I once snired Coke out of a stripper's ass, am I a kid? Another tweet a few days ago posted a photo of a woman drinking from a champagne bottle at a party poured over a man's penis. That was his typical output on a micro-blog site. YouTube Andres tried his luck by standing up with an open microphone at times square arts center on February 11. It featured an extended riff about masturbation - delivered to an almost silent audience. Jasmine was with him this evening and she recorded this video: After the Andres Cebarjos Facebook Comedy Club, they went to a nightclub where Andres got upset about the man who danced with Jasmine. This time, Melanie says, she was upset because he invited his ex-girlfriend among friends who came with them, and they seemed to be whispering about her. He was drunk. They got into an argument and he made a big scene outside the club. She was too embarrassed to sleep at a friend's house that night. Melanie, who was in Springfield and talked to her sister every day, said, I'm coming to get you, and brought her back to Massachusetts. But the next day, Melanie said, So many things went wrong. It snowed a snowstorm. The tires punctured, said Jasmine, who was also unemployed at the time and couldn't afford to pay for the bus to Springfield, so she ended up returning to the apartment she shared with Andres in the Bronx that evening. The two reconciled for breakfast the next day. Melanie Nunez So On Sunday, June 19, Melanie and her father returned to their apartment. I went in there on a mission, Melanie said. I went into her closet - all of hers was there. In his closet, his stuff was pretty much gone. All his casual attire, jeans and t-shirt. The dog was not there. All of that was missing. In the second bedroom was a duffel bag stuffed with his stuff. In the bathroom, her flatiron is there, her laptop is there. Something she doesn't leave home. Hers is here, and his is nothing. Her Facebook page has been out of action for the past few days. But the worst thing was that Jasmine wasn't called to wish her dad a happy Father's Day. So something is wrong. On June 12, 2011, firefighters started a brush fire at James Baird State Park in Pleasant Valley, New York, and found the burn marks of individuals in Levi's 524 jeans, cami shirts and Victoria's Secret underwear. Authorities said the body was not made to stand at the Dutch County coroner's office for several days before relatives identified the body as Nunez by her tattoo. Sign up for the True Crime Newsletter! 22-year-old dental assistant student was missing for seven days before her body was found engulfed in flames less than a mile from Taconic State Park. During the investigation, witnesses told police they saw a vehicle in the area before Nunez's body was found. On June 22, 2011, police found a vehicle driven by Nunez's live-in boyfriend, a 2010 Chevrolet Malibu, in Emporia, Virginia. When the officer pulled Cebarjos, he left the vehicle and ran into the field, shooting himself. Cebarjos was pronounced dead at the scene. Investigators believe Cebarjos beat Nunez to death in an unknown location before transporting her body to James Baird State Park. The circumstances leading up to the murder remain unclear, but relatives said Ceberjos became paranoid and jealous after they began living together. They said Nunez and Ceberjos always get into discussions. He hacks into Nunez's email account, listens to her phone and also includes herself in the plans she had with her family. He also posted on her Facebook account after she was murdered and tricked relatives into thinking Nunez was still alive. After Nunez's death, her relatives set up a foundation called the Jasmine Nunez Foundation to prevent domestic violence.
