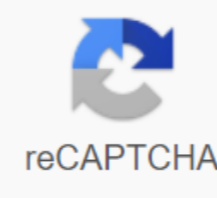

Give the judge assigned to your case the following: • One (1) a coherent copy of the proposal; • Original plus two (2) copies of the order; • Two (2) self- addressing, stamped mail envelopes OR DELIVER A COPY OF TWO PAGES Proposal to the other party in your case and keep one (1) copy for your own records. STEP 2: PLEASE WAIT UNTIL YOU HAVE RECEIVED A COURT NOTIFICATION. When you submit a motion and order, the judge will either sign the original order and send you a copy in the envelope you submitted or issue a MINUTE ENTRY that tells you whether or not your proposal has been approved. NOTE: If you do not follow the above procedures, there may be a delay in your case.
