The Western Pennsylvania Regional Data Center (WPRDC) is a project of the University Center of Social and Urban Research (UCSUR) of the University of Pittsburgh (University) in collaboration with the City of Pittsburgh and the County of Allegheny in Pennsylvania. The WPRDC and the WPRDC project are supported by a grant from the Richard King Mellon Foundation. This Data Usage Agreement includes the terms and conditions that you must agree to before you access the data or use it when you deposit it with the WPRDC. The WPRDC deposit data is not intended for this purpose and should contain non-public information as defined below. Non-public information within the meaning of this Agreement is information that may not be disclosed to the public for the following reasons: The information is exempt from disclosure or prohibited from providing the information in accordance with the laws and regulations of the state and federal government, including the Pennsylvania Right to Know Act, 65 p. 67.101 ff., the Criminal History Record Information Act, 18 Pa.C.S. 9101-9183, the Health Insurance Transfer and Accountability Act (HIPAA) and other applicable data protection laws; The information is subject to a contractual obligation of confidentiality; The information is subject to confidentiality and fiduciary duties; or the information is private, proprietary or privileged. This record represents information about county, municipal, school district, and water/canal tax liens by parcel (and, if available, real estate identification number). This record contains the name of the municipality, county, or school district, the day the lien was filed, and the tax amount on the filing date. This data is based on records submitted in 1995. This dataset will be updated with the submissions of the previous month as new data becomes available (usually just before the beginning of the month). Delinquent Tax Docket numbers are not unique identifiers. Instead, users must combine the Delinquent Tax Docket number, tax year, and lien description. This data set represents our best efforts to describe the state of tax liens.
