For those who suggest a change of course (the majority for this matter) any senator for life is entitled to an optional mandate based on the 2018 Act's former 108 heads and the february 18, 2006 constitution's former heads of state. In this sense, as a senator, for life, every senator will tolerate constitutional inconcenscencies in the context of MPs, especially those who are provided in Section 108 for any other alternative term. In our reflection, we will try to answer some questions raised by this approach, especially given that, referring to a life, it would be a deadly sanction for those who benefit from it. And then, by asking the question of the possibility of being a candidate, why do we start a debate on a qualification rather than a non-conformity? These are the fundamental questions of our reflection, as well as many other subordinate questions that can arise indefinitely, especially with the same period of office, which in principle, still deserves the renewal of the term. This debate is evidence of the flaws in our constitutional law that cause the legal texts crisis. The latter is not resolved by the theory in many Chicago views, but is primarily by interpretation that Parliament can give interpretation or reform by adopting the Constitution, but also by interpreting that judges, in this case, can give constitutional judges. The content of this sentence is this: In addition to the nine members mentioned above, the former president of the Republic is a member of the Constitutional Council for life legally. We believe in the question of whether a senator can be a candidate for life, not about inconsistency, but about the potential of his ability. Because if we are to be a senator who has served only one term, he still has the right to renew it from a constitutional point of view. He could return as a candidate and if elected, that's where his inconsistency in his inauguration is questioned and at the end of his term, he has the chance to become a senator again based on the 18 February 2006 Constitution 110, not for the 2011 expiration but for the suspension if we still want to remain in the relationship between Article 6 of the Act on the former heads of state 108 and the above constitution 110. This is relatively what happened in France in 2004 when V. de Estan, now no optional mandate. He came back to sit on the board where the Constitution gives him the right to life. This is a minor analysis like many other data from our great Congolese professors and intellectuals. It does not appear to give a good answer to the debate. Rather, it provides a different head and will probably serve to give a binding opinion to the legislature (TheConstitution) or the constitutional judge. We didn't want to go to the question of mandate success or not, but rather we wanted to give an analysis for life in the DRC, a concept whose studies are rare in our legal environment but which are done in almost every way these years. We believe that, as a result, the position of a senator for life is not a good reason to say no to the potential new term of the former president's office of the Republic. A senator for life is not punished for political ambitions, especially if he served only one term. As president in France, we believe that this position is given to former presidents to give them the right to share in the identity of the loyal services in the country and to allow them to promote the winds in power. Inconsistency cannot be in any way that if the Constitution is not explicitly prohibited and the election law is not prohibited, then this status has not been established because of its ability. As far as our law is concerned, if the constitutional court is not regulated in interpreting these provisions, this issue will arise in the presidential inauguration for the life of Thomas Hokomann, who believes that if Nicolas Sarkozy wins the presidential election (in 2017), he will be the first person to be elected to the House.
