


In our reflection, we will try to answer some questions raised by this approach, especially given that, referring to a life, it would be a deadly sanction for those who benefit from it. And then, by asking the question of the possibility of being a candidate, why do we start a debate on a qualification rather than a non-conformity? These are the fundamental questions of our reflection, as well as many other subordinate questions that can arise indefinitely, especially with the same period of office, which in principle, still deserves the renewal of the term. This debate is evidence of the flaws in our constitutional law that cause the legal texts crisis.
