If you've never had a license before, some countries require you to get a learning license first. If you are under the age of 18 or 19, you may also need to pass a driver education course. No learning permission is required in other countries, but you may need to complete more steps than a driver with a current or past license. Student licenses -- sometimes referred to as temporary, temporary or instructional permits -- are routinely issued to minors between the ages of 15 and 18. However, some states require first-time drivers to have a learning license for a certain period of time before they can apply for a standard license. For example, first-time drivers in Delaware must have a student's license for at least 10 days before they can take a road test for a standard permit. In Virginia, first-time drivers must either have a student's license for at least 60 days or successfully pass a driver's education course before being allowed to take a road skills test for a standard license. Virginia drivers under the age of 19 must hold a student's license for at least nine months and undergo a driver's education course before they can apply for one. Many states do not require first-time drivers to get a learning license. Instead, they must meet additional requirements. For example, all applicants in New Hampshire are required to apply, two forms of identification and proof of residence of the state, pay a fee and pass a vision test. Those who have never had a driver's license must also successfully complete a knowledge and road test. First-time drivers must successfully complete a driver education course and record 40 hours of supervised driving time before they can apply for a standard licence. If a person already has a license and moves to another country, they are usually not obliged to obtain a learning permit in the new country first. Instead, it applies for a license from the local motor vehicle department. Typically, he surrenders his previous license, gives his Social Security number and fingerprint, poses for a photo, submits proof of identity, age, local address and citizenship status, and pays a fee. Depending on the country, additional requirements may include successful vision test, knowledge test and road skills test. Foreign nationals with a valid driver's license outside the country are usually also not required to obtain a student license before obtaining a license in their U.S. state or territory of residence. For example, in the District of Columbia, foreign nationals are entitled to a D.C. license if they will be in the states for at least six months. submit submit request, provide proof of residence and social security number, do not owe D.C. or unpaid traffic tickets to other jurisdictions, pay compensation and pass any necessary vision, knowledge and road tests. But the Social Security Administration says non-citizens don't usually need a Social Security number to get a driver's license. Scoring points is a good thing, unless it's on your driving record. Auto insurance companies don't rely on the state's point department systems for motor vehicles -- they use their own motor vehicle divisions and insurance companies use point systems to track driving performance, but these are separate estimates. DMV points apply when you are convicted of certain traffic violations. If you collect too many points within a certain period of time, the license is usually suspended or revoked. Insurers generally don't pay much attention to DMV points because they use their own points system when deciding how much to increase your rate. Based on violations, your rates rise by a predetermined amount at certain thresholds. For example, one Minnesota insurer awards four points for a collectable accident with a claim of \$750 or more and a three-point speeding judgment by 10 mph above the limit. Its surcharges schedule shows that the rate for a driver with seven points would multiply by 1.27 - or a 27 percent increase, says Penny Gusner, consumer analyst for CarInsurance.com.2. Not All States Use Point SystemsThere are nine states that don't use points to track bad drivers, but that doesn't mean you've gotten away with it if you're accumulating violations. These conditions simply track your driving record to determine whether your license should be revoked or revoked. For example, in Oregon, if you have four accidents or four convictions -- or a combination of four -- over a 24-month period, you lose your license for 30 days. Points can stick to your record for one to 10 years, depending on the offense and your state laws In many states, driving record points dog you for two to three years for minor offenses, but there are exceptions. For example, in Virginia and Michigan, points are held for two years from the date of conviction. In California, points for minor offenses remain on your record for three years, but DUI and hit-and-run points last 10 years. In Nevada, points remain on your record for only a year, but major violations, including DUI, result in automatic license suspension, not points. 7. When children are included, seat belt tickets can mean points You usually won't get points if they're listed for not wearing a seat belt, but in New York, if you're penalized for a child in a car under 16 without a seat belt, the offense adds three points to your driving record.10. In some states, if you get smashed by a red light camera, you get a ticket, but not pointsTypically, if you get a penalty for running a red light, you also get driver's license points. But in some states, if you get caught in a red light camera, you don't get points. Other states nail down on points for running red lights regardless of whether a camera or a cop busts you. For example, Arizona estimates two points for red light tickets, either from the camera or the police.
