Gymboree(Gymboree sells clothing and accessories for children. Facebook/Gymboree) Gymboree closes hundreds of stores. Children's clothing store Gymboree, which filed for chapter 11 bankruptcy protection in June, confirmed it would close 350 of its 1,281 stores. The closures will affect two other chains that the company operates: Janie and Jack, which sells branded children's clothing, and Crazy 8, its cheap children's clothing company. The company has more than 11,000 employees. The right size of our store footprint is a central part of our efforts to ensure Gymboree emerges from this restructuring process as a stronger and more competitive organization, with greater financial flexibility to invest in our future, Gymboree CEO Daniel Griesemer said in a statement. Gymboree joins a long list of other retailers who filed for bankruptcy and closed stores this year, including Rue21, Payless ShoeSource, Hhgregg, Limited, RadioShack, BCBG, Wet Seal, Gordmans, Eastern Outfitters and Gander Mountain.
