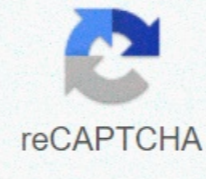

The affected model's legs can swing out of position, which then makes the chair unstable and more likely to fall. The high chairs were sold between October 2016 and December 2017 at Walmart, and have the model number: 1969721. You can find this number on either the label on the back of the booster or the underside of the toddler seat. Graco has received 38 reports of his legs turning out of position, resulting in five injuries to children who suffered bumps and bruises when the high chair fell over. Selina Tedesco, product analyst at the Good Housekeeping Institute, says that recalls like this serve as a good reminder for parents to always make sure their child's high chair is safe. Every child under two spends a lot of time in their high chairs, but even when they're strapped in, you can't assume they're completely safe, she explains. Good Housekeeping Institute recommends taking the following precautions: • Choose a model with a wide foundation for stability. • When choosing a highchair, look for one that has a waist strap and a crotch strap and use them both each time. • If the highchair you are buying does not have a crotch strap, make sure it has a post that runs between a child's leg to prevent them from slipping down and getting trapped under the tray. • Make sure that the locking unit of a foldable highchair is locked each time you set up the chair. • Never allow a child to get up in a highchair. • Place high chairs away from tables, counters or walls. If a baby can reach them, he can use them to push off and make it overturn. • Do not use a children's highchair above the weight limit indicated for the product, or allow older or heavier children to climb on or sit in an infant's highchair. • For a highchair certified by JPMA. Medicare will help pay for some of the costs when you buy an elevator chair. Your doctor needs to prescribe the lifting chair, and you'll need to buy it from a Medicare-approved provider to secure coverage. Medicare will cover some of the cost of medical devices, including an elevator chair. These are special chairs that help lift you from a sitting position to standing position. They can be very useful when you have mobility problems and difficulty getting up from a sitting position. The chair part of the lift chair is not considered medically necessary, and therefore it is not covered. You are eligible for coverage of an elevator chair if you are enrolled in Medicare Part B. To qualify for Medicare, you must be at least 65 years old or have other qualifying medical conditions. These conditions may include a severe disability, terminal kidney disease or ALS (amyotrophic lateral sclerosis). If you have Medicare Advantage, you are still eligible to receive an elevator chair. Medicare Advantage or Medicare Part C is when you choose a private insurer to cover your Medicare benefits. Because Medicare Advantage companies must cover every aspect that native Medicare does, you should get at least the same amount of coverage, if not additional benefits. You must live in a residential building to qualify for this benefit. Medicare Part B is the part of Medicare that pays for the lifting mechanism of the elevator chair. With Part B, you must first meet your deductible, which is \$198 in 2020. Once you've met the deductible, you'll pay 20% of the Medicare-approved amount for the lifting mechanism. You will also pay 100% of the remaining cost of the chair. Medicare-registered doctors and providers Medicare will only pay for an elevator chair if the doctor who prescribes it is a Medicare provider. Medicare also requires the provider to be enrolled in Medicare. When searching for elevator chairs, it is important to ask the company if they are enrolled in Medicare and accept assignments.
