The Rhode Island Judicial Website has a database or public portal in which individuals may have access to case information for certain types of cases, including most criminal cases in district courts, superior and superior. The public portal enables users to access information about their cases including case numbers, charges, future court dates, bench rulings, outstanding court debts and payments.
