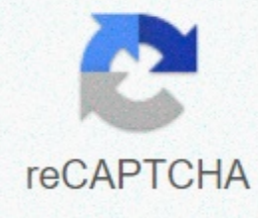

Every post or letter is checked by pennington County Jail before delivery. Any letter containing an obscene and inappropriate message is blocked for security reasons. Email rules often vary from setup to setup. Pennington County Jail has no limit on pages for the letters an inmate can receive. Nothing larger than 8 inches or 10 inches is allowed. Photos can be sent and are counted on the page, note Polaroid is not allowed. No obscene messages to send and no business can be done with the email. All incoming emails must be used in correct details (full name, booking number, address of the institution) No abbreviations in the message. Emails that contain images or messages outside the envelope are restricted and rejected. With Jail Mail app, you can write letters, send photos and money directly from your phones. Pennington County Jail has listed the app for both Android and first-time mobile users. Now with just one click, you can send a message to your inmate from anywhere. Postcards are a convenient way to communicate with your inmate. You can customize your postcard by adding your photo, a perfect solution to send personal photos without hassle. Contact Pennington County Jail for postcard restrictions because some facilities only allow photos as a graphic page of a postcard. Nudity and glued or tape is not allowed. Each year, this facility has 5520 bookings, with a daily average of 276 inmates and a staff of 69. Inmates range from low-level offenders to criminals who are tried for violent crimes such as robbery, rape and murder. Therefore, the security level must be high. Pennington County Jail correctional officers are armed with Mace and charged with physical assault protect themselves from violence to visitors and inmates. All the men and women being held in the Pennington County Jail are either awaiting trial or have been convicted in the Pennington County Court system and sentenced to one year or less. The Pennington County Jail also houses inmates arrested by the county's municipal police departments. A full list of towns and cities can be found below. Family and friends of inmates are allowed: • Receive calls from inmates, • Give them commissariat money • Receive and send them mail • Schedule a time for a visit. Convicted and convicted inmates If an inmate is sentenced to one year or more, they are transferred to the South Dakota State Prison System or the Federal Bureau of Prisons. Inmates convicted of a misdemeanor and/or sentenced to less than a year of state-related crimes will serve their time in prison. Illegal immigrants convicted of a state or federal crime will first seek time and then be taken into ICE custody for deportation. Deportation.
