Sur La Table filed for bankruptcy on Wednesday, joining a mounting list of retailers seeking Chapter 11 bankruptcy protection as a result of the coronavirus outbreak. The company, best known for its upscale kitchens and culinary classes, will close more than 50 stores that are part of bankruptcy proceedings. It will continue to operate high-performing stores and plans to sell 70 of its locations to a private equity firm, Fortress Investments. This sale process will revitalize Sur La Table, located to thrive in the retail environment after COVID-19, said Jason Goldberger, CEO of Sur La Table in a statement. The Seattle-based company cut 20% of its workforce last month as a result of a slump in sales due to the pandemic. The company has also been particularly hard hit by the loss of its cooking classes and activities that have been stopped or restricted to prevent the spread of the virus.
