In Ohio, like most other states, if you want to be a professional contractor, you need to get a license. However, the requirements for the license and where you want to obtain it will vary depending on the type of work you are performing. Whether you're planning to work or a handyman or registered engineer, it's important to know exactly what type of license you need for a specific project in your city or county. In Ohio, contractors are only required to be licensed by the Ohio Construction Industry Licensing Commission for the following transactions: Having an electrical plumbing HVAC Hydronics refrigeration state license does not allow cities or counties in the state to meet additional requirements. We recommend contacting your local authority to find out what you need, including licenses, inspections and permits for each project. You must be 18 years old and a U.S. citizen or legal alien before applying for a license for an Ohio state contractor, and unless you are an engineer, you must have at least five years of experience in your trade. State-registered engineers require just three years of experience. You can download the application package from the Ohio Department of Commerce website. The application must be printed, filled out and published before it can be mailed to OCILB along with a \$25 application fee. If you pass state and federal background checks and have a liability range of at least \$500,000, you must review the transaction. Most contractor licenses require five years of experience and require you to take an exam.
