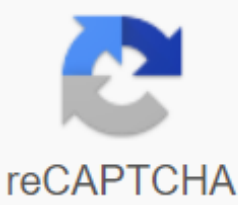

That they will not disclose the names, addresses, email address, telephone and fax or telex numbers of any contacts of any of the parties to third parties to third parties to third parties; and that they each acknowledge such contracts as the respective party's exclusive property, and that they will not enter into any direct negotiations or transactions with such contracts disclosed by the other party and, E. That they further undertake not to enter into business transactions with banks, investors, sources of funds or other bodies, whose name is given by one of the parties to this Agreement, unless written permission is obtained from the other party (ie) to do so. For the sake of this Agreement, it does not matter about information obtained from a natural or legal person. The parties also undertake no obligation to use a third party to circumvent this clause. F. That in the event of circumvention of this Agreement by either party, directly or indirectly, the circumspect party shall be entitled to a legal monetary penalty equal to the maximum service it shall realize from such transaction plus all expenses, including but not limited to, all legal costs and expenses incurred to recover the lost income. G. All considerations, benefits, bonuses, participation fees and/or commissions received as a result of contributions from the parties to the agreement, related to all transactions will be allocated as mutually agreed. H. This Agreement is valid for any transaction between the parties herein and shall be governed by the enforceable law of The Australian Courts, Canada Courts, USA Courts, UK Courts, Singapore Courts, or under Swiss Law in Zurich, in the event of dispute, the arbitration laws of the States will apply. I. The Signing Parties hereby accept such elected jurisdiction as the exclusive location. The duration of the agreement shall be continued for five (5) years from the date herein. A.
