Many parents pay thousands of dollars each year to send their kids to private schools - especially those living in areas where public schools are of poor quality. A 2014 comparison by real estate site Trulia found that in zip codes with high-rated public schools, only 4% of children go to private schools, compared with 19% of children in zip codes with low-rated public schools. However, that doesn't mean that parents who live in good school districts are spending less overall. Homes in those high-run school districts usually cost much more than other homes in the same area - about 32% more, according to the Trulia study. So for many families, the extra cost of housing adds up to more than what they paid for a private school. That is, parents who want the best possible education for their children have a hard choice to make: Directly for private school, or indirect payment for a house near a good public school. To figure out who is best, they need to know just how these two cost comparisons, and what options they have to keep costs down. About 4.5 million U.S. children enrolled in private schools between 2011 and 2012, according to the National Center for Education Statistics (NCES). More than 80% of these students were in schools with some form of religious affiliation. About 43% were Catholic in schools, while another 37% went to schools generally known as Christian, Jewish or a particular Christian religion. About 68% of all private schools have religious orientation, while 32% are non-religious. The average cost of private school tuition for the 2011-2012 school year was \$10,740 per child, according to NCES. This is a significant burden for a middle-class family. In 2014, the median national household income in the United States was \$53,657, according to the U.S. Census Bureau. That means a middle-income family had to spend about 20% of their income sending only one child to private school, and 40% for two children. However, the cost of tuition varies significantly depending on the type of school. The average tuition fee was \$6,890 a year for Catholic schools, \$8,690 for other madrassas and a whopping \$21,510 for non-sectarian schools. So a middle-income family paid less than 13% of their income to send a child to a Catholic school, but more than 40% for a secular school. Public school fees make private school fees easy to identify - just a fixed number of dollars a year. Calculating the cost of public school is much more complicated. You need to know which neighborhoods parents choose for their schools, how much it costs to live in those neighborhoods, and how it compares to the cost of living in other and nearby neighborhoods. A good place to start with niche is the website that rates and compares U.S. school districts based on factors such as student test scores, graduation rates, health and safety ratings, and reviews from parents and students. Each year, niche lists 10 school districts as it rates the best in America. For 2016, the school district is number one on the treddyffrin-Easttown school district's niche list. In that case, the public school family saves a total of \$70,000 during each of their children's school years. Keeping school costs under control in general, public schools - even those in expensive neighborhoods - seem to be a better deal for families with multiple children, while private schools tend to be of better value to only children. However, this rule is not true for everyone. Parents who choose the right private school can take tuition fees to an affordable level, even with a few kids at school at once. And on the contrary, smart choices about housing can make living in a large school district an affordable choice, even with only one child. Private school options are one way a more affordable private school is to choose a lower-tuition school. As noted above, madrassas - especially Catholic ones - tend to be much more affordable than non-sectarian private schools. According to NCES statistics, one family could send two children to a Catholic school for an average cost of \$13,780 a year. That's a little less than the extra \$14,436 a year it costs to live in Tredyffrin County instead of Pauley. Another private school option is a Montessori school. Private school scholarship families who have trouble affording private school tuition can sometimes make it available financially through scholarships and other forms of donations. Some schools have their own grants programs, while others participate in national, regional or government scholarship programs. Funding sources include the Children's Scholarship Fund. Originally started as the Washington Scholarship Fund, the Children's Scholarship Fund (CSF) now provides part of scholarships for low-income families nationwide. Scholarships cover up to 75% of tuition fees, with an average of \$1,700 per child. They can be used for any type of school - religious, secular, or even home school. To qualify for scholarships, families must meet the child in elementary school and meet the national school lunch program's income guidelines. In 2015-15, the fund offered scholarships to more than 24,000 students. To apply for a scholarship, parents must contact one of the CSF partner programs in 16 states; Young Scholars Program. Run by the Jack Kenneth Cook Foundation, the Young Scholars Program provides scholarships for middle and high school students with high grades. Each year, about 60 students receive scholarships that they can use for boarding school, day school or parochial (religious) school. In addition to financial support, young students receive academic advice, access to special enrichment programs, and other resources. Families earning up to \$95,000 can apply, but most young scholars come from families with incomes below \$60,000. The application period runs from January to April, and students know whether they are eligible for help. A better chance. The program aims to paint students in grades 4-9 that have good overall grades and are active in extra-program activities. The program does not actually provide scholarship funding, but it refers qualified students to more than 300 middle and high schools across the country - whether religious or secular - and helps them apply for donations from those schools. You can enter your state and region into the site's advanced search engine, then choose your criteria for school quality, price, and other features that matter to you, such as crime rates or walking. However, to use this feature, you need to subscribe to the site, which costs \$40 a month, \$90 per quarter, or \$192 per year. Another way to afford a home in a high-ranking school district is to deliberately choose to live in a smaller house. In Tredyffrin Township, PA, for example, lists three-bedroom homes for as much as \$390,000. Mortgage payments on a home like this will come to about \$1,912 a month – savings of \$698 a month, or \$8,376 a year, compared to the median house price.
