What is an arrest warrant? Warrants have two common categories: arrest warrants and arrest warrants. Arrest warrants are legal documents ordering law enforcement agencies to arrest the person named by order without delay. An arrest warrant is made in one of two ways: a complaint or indictment. The arrest warrant differs from the arrest warrant (that is, a summons for a person to appear in court) where they are acted on fairly quickly. If your order is issued at the request of law enforcement, they most likely won't waste time pursuing you. The reasonable thing to do is to ask a lawyer and make no statement until you can talk to them. What is bench guarantee? A bench warrant is an order issued by a Shelby County judge, generally because a defendant does not appear for their court case. These kinds of warrants are much easier for a Memphis warrant attorney to set aside than an arrest warrant. If you have a bench guarantee, you will absolutely need a lawyer to file yourself in court and ask the court to revoke the order. What is a complaint file? A complaint declaration is a charging tool used to get an arrest warrant. This document must give the necessary facts that form the possible cause that a crime has occurred. Generally, if an officer personally witnesses a crime taking place, he can make an arrest without an arrest warrant, complete a complaint and submit it to the judge or judge for review. If the judge or judge agrees that the possible cause for the arrest, they will sign an arrest warrant ordering the continued detention of the individual and establishing a bond. The Tennessee Act makes an exception for officers' personal witnesses of crimes in domestic violence cases. If an individual witnesses a domestic violence incident, they can make themselves sufficient for a complaint and the officer must make an arrest based on that witness's testimony. Possible causes must still be established. In some cases, a complaint is made before the arrest where the suspect has left the scene and cannot be placed when taking an oath complaints and arrest warrants. The arrest warrant still works the same. What is the indictment? An indictment is a document filed by the district attorney after the jury reviewed a case and returned a real bill. An indictment can be sought before or after arrest. If an arrest is made first, the case will begin in the general court session. If the matter is not resolved in general sessions, the case will proceed to a jury where an indictment will be sought. If no arrests are made before prosecution, the process is called a secret indictment. Secret indictments are often sought when police or district attorneys don't want suspects to know they're under investigation. All federal cases follow a secret indictment. To get an indictment, the district attorney and law enforcement agency draft a statement of possible cause and present this document and testimony (not open to the public) to the jury. Jurors are given the necessary laws and make a decision on whether the possible cause is met. If the jury determines that a possible cause exists, the jury returns a real bill. This real bill is turned into an indictment and submitted to the clerk of the court. The district attorney then presented the indictment to a judge who issued an arrest warrant known as capias and laid bonds. If the jury determines that the possible cause does not exist, it returns a no real bill, no indictment is filed and no order has been issued. How do I know if I have an arrest warrant? There are several ways to find out if you have an arrest warrant in Memphis. If the arrest warrant has been made public, you can visit the Shelby County warrant website and enter your information or you can contact the Shelby County fugitive team and request it. If the arrest warrant has not been announced, as in a confidential indictment, you will need a Memphis secured attorney to contact the Shelby County fugitive team or the Shelby County District Attorney's office. I didn't do anything, but I got an arrest warrant? While possible, it is very difficult to avoid arrest once a Memphis arrest warrant has been issued. However, if some evidence exists that specifically exonerates you, you need to contact a Memphis secured attorney immediately. It's possible that a Memphis attorney can contact the district attorney, present that evidence, and have an order in place. Otherwise, you'll need to contact a Memphis criminal defense attorney and go with that attorney to surrender. With a lawyer surrendering, that lawyer can negotiate a lower bond so you get out of jail much easier and faster. What should I do if I have an arrest warrant? Call a Memphis attorney. This cannot be emphasized enough. If There's a warrant, the police are looking for you. Best Best the scenario is that we can get them to stop looking for you. In the worst case, we may negotiate the terms of your surrender. How do I know if it's an arrest warrant? Call us and we can usually let you know over the phone. Otherwise, ask yourself whether you missed a court date. If you have, most likely it is a bench guarantee. If you don't have a court date, it's most likely an arrest warrant. Can a lawyer help me? No matter what kind of guarantee you will need a lawyer at some point. The sooner you retain a lawyer, the better. It was a sad day when defendants came out to surrender without the advice of lawyers, only to provide more evidence to the police to prove their case or to see evidence dissipated due to the delay of retaining a lawyer.
