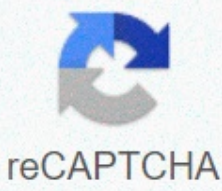

Which credit cards does the secretary accept? The clerk currently accepts American Express, Visa and MasterCard for online transactions. What if I'm not the cardholder? You must be an authorized user of that credit card to make an online purchase on the Broward County Clerk of Courts website. Will I receive a confirmation of my transaction? Once the transaction is complete, you will receive a list of items purchased, as well as a confirmation number if you need to contact the office in the future. After pressing Confirm Purchase, I received a message that my credit/debit card was rejected. I know my card is good, what's going on? The clerk uses a verification service to approve all online credit/debit card transactions. This service uses the billing address for verification. If the billing address you entered in the registration form does not match the address specified with the credit card issuer, the transaction will be denied. If this happens, secure a recent copy of your credit card billing settlement and enter the address exactly as it appears on this statement. To pay a ticket you can choose an option below: Pay online: Use online fine payment service. This option is only available when the quote is entered into our system. [The Broward County Clerk of Courts Online Fine Payment service is offered as a convenience to the public. Use of this service in no way diminishes the defendant from the responsibility to pay a fine, or make a choice on time, if the quote is not available for access within the 10 day limit.] Pay at AMSCOT: Visit any AMSCOT location in Florida to pay cash on parking issues. Pay by post: Send payment to Clerk of Courts Parking Division, P.O. Box 14610, Fort Lauderdale, FL 33302-4610. [An envelope was given by the issuing officer to post in the payment. Add the payment to the citation envelope and add your name and address to the return section. Place a stamp on the envelope before sending.] Pay in person: Pay by cheque, money order or cash at a parking/code enforcement location. See the courthouse locations under the contact information section of this page. IF YOU ARE NOT or the vehicle is not owned by you. If you are not the owner of the vehicle listed in the parking violation, or you were not the operator of the vehicle at the time of the breach, you can avoid the necessary personal court appearance by completing the parking violation Identify declaration that can be purchased from the secretary's website and must be sent to the division before the 10 business day due date of the breach. Note: If the license plate renewal is suspended due to unpaid parking quotes, you will not be subject to a personal check. This page lists the various offices across Florida by county.
