Custodians work to keep school buildings clean. Your working hours vary between the day shift and the afternoon shift. The day shift is cleaned after lunch and other student activities, and the afternoon shift does a deep cleaning, such as aspiration and mopping floors. Lead custodians, who manage cleaning crews, do slightly more than the average prisoner. The average annual salary of a custodian in the U.S. is about \$22,210, as of 2012, according to the Bureau of Labor Statistics. That's about \$10.68 an hour. The pay rate is slightly higher for school custodians. Some areas of the country pay school custodians better than others, and pay may also differ in the same area between school districts. The BLS indicates that as of 2010, lower-paid jobs offer about \$7.86 an hour and the highest-paid positions reached about \$17.88 an hour. A comparison of wages from 2012 shows that some parts of the country tend to pay more. New York school custodians earned an average salary of \$32,000, but those in Florida earned only an average of \$26,000 a year. When looking at the salary of a particular area, the cost of living is also taken into account. For example, Indiana school custodians earned about \$29,000 a year, just \$3,000 less than New York, where the cost of living is higher. Part of the pay package for school custodians includes benefits. Middle school prisoners enjoy the same holidays as other teachers, with the exception of the summer holidays, when some of the deepest cleaning projects are completed. In addition, the position is usually of the medical and retirement benefits that can not offer the small companies that hire a custodian. According to a 2002 study by the National Education Association, about 67 percent of school custodians are paid by the hour. The rest are paid an annual salary. Although their degrees vary according to the branch of service, they are at the highest level of military management in times of peace and war. Work for a general officer depends on the field of race, rank and assignment. The generals are responsible for high-level decision-making and the personnel in their command. General officials serve in administrative combat and non-combat positions, as well as in professions such as law, medicine and ministry. In the Army, Air Force and Marines, the general term is used for officers in O-7 pay grades on O-10. The corresponding full titles are Brigadier General (BG), Lieutenant General (LTG), Major General (MG) and General (GEN). Equivalent ranges in the four services carry the same badge. A one-star general, a brigadier general, wears a single silver star. A lieutenant general carries two stars, a major general carries three, and a general wears four. During the war alone, an additional star can be added by the Army, Navy and Air Force. A range of a Navy star is the same as the rank of a star in the other services. The corresponding titles for Navy General Officers are as follows: O-7 Brigadier General = Lower Half Rear Admiral (RDML) O-8 Lieutenant General = Rear Admiral Upper Half (RADM) O-9 Major General = Vice Admiral (VADM) O-10 General = Admiral (ADM) There are three ways to become an officer in the Armed Forces. Most officers are commissioned after graduating from a university or university, often having won a degree through a reserve officers training program (ROTC). Civil servants can also be commissioned after completing a professional degree such as medicine, dentistry or law. A select number of officers are graduates from one of the service academies, be it the U.S. Military Academy (Army) at West Point, the U.S. Naval Academy in Annapolis (Navy and Marines) or the U.S. Air Force Academy in Colorado Springs. Admission to academies is highly competitive and requires the appointment of a U.S. official, usually a senator or a member of Congress. Enlisted service members, who have exemplary records, can apply to the School of Official Candidates (OCS), which trains soldiers, who may not have a university degree, to serve as officers. Most officers begin their Army careers as second lieutenant (pay grade O-1), although newly graduated doctors, dentists and veterinarians begin the rank of captain (O-3). Depending on the needs of the military, an experienced professional can even enter a higher rank, although it is rare. To become a general, you must be promoted across all ranks to O-7, which usually requires distinction in the chosen field and at least 20 years of military service. It is very rare for an officer trained through the OCS to reach the of general. The general officers work in a variety of environments, depending on their field of career. A general officer can run a hospital or a group of satellite clinics. You can be superintendent of an educational institution, such as one of the service academies or advanced official training The general officers serve as strategic and tactical leaders in peacetime and when the nation is at war. A general brigade salary starts at \$8,640.60 a month. The maximum salary for a general is \$15,800.10 a month, for an O-10 with more than 40 years of military service. That's a salary range of \$103,687.20 to \$189,601.20 annually, depending on the range and years of service. General officials receive a housing benefit, adjusted for the local cost of living, as well as medical, dental and vision benefits. As with anyone in the military with more than 20 years of service, general officials are entitled to a pension after military retirement. A retired general can move on to a civil career with the government or the private sector, usually at a high level of responsibility and pay. The U.S. Bureau of Labor Statistics does not project job prospects for military jobs. The needs of the military dictate the number of places available to officers in the armed services. Becoming a general is reaching the pinnacle of a military career. Of the many officers in the armed forces, only a select few will rise to the ranks of the general officers. Private schools can have different salary scales due to factors such as student size, funding sources and accreditation requirements. Teachers choose to work in private schools for reasons such as manageable class sizes and more freedom from teaching practices. Teachers at U.S. private elementary and middle schools averaged \$38,255 a year in 2010, according to the Bureau of Labor Statistics. This differs from the professor's salary survey from the National Center for Education Statistics from 2007-2008, which lists an average annual income of \$33,160. Although the basic educational requirements for teaching at the elementary level are the same as those in secondary school, primary and secondary teachers usually pay less. The BLS survey lists the annual income of private school teachers at high school level as \$50,797, while the NCES survey lists \$39,890. Secondary school teachers are more likely to be hired based on their experience in their subject areas. Therefore, they are more likely to be hired based on their experience and higher education achievements. NCES survey shows average base salary for public school teachers of all levels \$49,630. Think Outside the (School) Box Every college and university will have its own selection of scholarships and scholarships funded by its own group of alumni and other interested donors. Scholarship sponsors will want to see the program's enrollment test before making their awards, so make sure it's ok in the undergraduate program application process as you apply for scholarships and scholarships.
